Section 96.7-2-a – Relief from Charges

STATEMENT OF THE CASE:

Herm Boonstra filed a timely appeal from an unemployment insurance decision dated June 22, 2005, reference 01, which indicated that he could be charged with unemployment insurance benefits paid to Matt G. Spaans. After reviewing all matters of record, the administrative law judge concludes that no additional evidence is necessary.

FINDINGS OF FACT:

Having examined all matters of record, the administrative law judge finds: Iowa Workforce Development has determined that Herm Boonstra is an agricultural employer who is not covered by the provisions of Iowa Code Chapter 96. Wages paid by Mr. Boonstra are not used to compute unemployment insurance benefits to which Mr. Spaans may be eligible.

REASONING AND CONCLUSIONS OF LAW:

Mr. Boonstra has not questioned Mr. Spaans' eligibility for benefits. The only question raised in this appeal is whether Mr. Boonstra may be charged for benefits paid to Mr. Spaans. Clearly he cannot be charged because the agency has determined that his agricultural operation is exempt from the provisions of Iowa Code Chapter 96.

DECISION:

The unemployment insurance decision dated June 22, 2005, reference 01, is modified. The claimant is entitled to receive unemployment insurance benefits, provided he is otherwise eligible. No benefits shall be charged to Herm Boonstra.
