Section 96.3-5 - Business Closure

STATEMENT OF THE CASE:

Wayne R. Simmons filed a timely appeal from an unemployment insurance decision dated May 13, 2004, reference 02, which denied his request to have his claim redetermined as being the result of a business closure. Due notice was issued for a telephone hearing to be held June 25, 2004. Because of a document submitted by Twister Chassis LLC identified for the record as Exhibit D-1, the administrative law judge concludes that no additional testimony is required.

FINDINGS OF FACT:

Having examined all matters of record, the administrative law judge finds: Prior to filing his present claim for unemployment insurance benefits, Wayne R. Simmons was last employed by Twister Chassis LLC in Knoxville, Iowa. The business has closed permanently.

REASONING AND CONCLUSIONS OF LAW:

The question is whether it is appropriate to recompute Mr. Simmons' benefits based upon the business closure provisions of Iowa Code Section 96.3-5. It is.

The statute allows for redetermination of benefits if the claimant's last employer has permanently gone out of business at the location where the individual was employed. The evidence in the record establishes that those conditions have been met. Mr. Simmons last worked for Twister Chassis LLC, which has ceased operations in Knoxville, Iowa. Redetermination is appropriate.

DECISION:

The unemployment insurance decision dated May 13, 2004, reference 02, is reversed. The claimant's unemployment insurance benefits shall be redetermined using the business closure provisions of the Employment Security Law.
