STATEMENT OF THE CASE:

On September 28, 2022, Kathryn Sanderson (claimant) filed a late appeal from the July 22, 2022 (reference 02) decision that denied benefits effective July 3, 2022, based on the deputy's conclusion the claimant was not partially unemployed within the meaning of the law. After due notice was issued, a hearing was held on October 25, 2022. Claimant participated. Christina Drahos represented the employer. The hearing in this matter was consolidated with the hearing in Appeal Number 22A-UI-17546-JT-T. Exhibits A, B and C were received into evidence. The administrative law judge took official notice of the following Agency administrative records: the reference 02 and 04 decisions, the reference 02 fact-finding record, DBRO and KCCO.

ISSUE:

Whether the appeal was timely. Whether there is good cause to treat the appeal as timely.

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds:

On July 20, 2022, Iowa Workforce Development mailed the July 20, 2022 (reference 01) decision to the claimant. The reference 01 decision concerned the claimant and employer Szabo Construction Company, Inc. The reference 01 decision held the claimant was "eligible for unemployment insurance benefits as long as you meet all other eligibility requirements," based on the deputy's conclusion the claimant was discharged on June 13, 2022 for no disqualifying reason.

On July 22, 2022, Iowa Workforce Development mailed the July 22, 2022 (reference 02) decision to the claimant's last-known address of record. The reference 02 decision concerned the claimant and employer Drahos & Senft CPAs P.C. The reference 02 decision denied benefits effective July 3, 2022, based on the deputy's conclusion the claimant was not partially unemployed within the meaning of the law. The reference 02 decision stated the decision would become final unless an appeal was postmarked by August 1, 2022 or was received by the

Appeals Section by that date. The claimant received the reference 02 decision in a timely manner, prior to the deadline for appeal. The claimant did not take steps to file an appeal from the decision by the appeal deadline.

On July 25, 2022, Iowa Workforce Development mailed the July 25, 2022 (reference 04) decision to the claimant's last-known address of record. The reference 04 decision held the claimant was overpaid \$222.00 in unemployment insurance benefits for the week that ended July 9, 2022, due to the July 22, 2022 that disqualified the claimant for benefits in connection with an able and available determination. The reference 04 decision stated the decision would become final unless an appeal was postmarked by August 4, 2022 or was received by the Appeals Section by that date. The claimant received the reference 04 decision in a timely manner, prior to the deadline for appeal. The claimant did not take steps to file an appeal from the decision by the appeal deadline.

At some point after the claimant received the overpayment decision, the claimant called lowa Workforce Development and spoke with an agency representative. The claimant's conversation with the agency representative did not include a discussion of whether the claimant should or should not file an appeal from the disqualification decision or the overpayment decision. While the claimant asserts the agency representative told her she "took care of everything" and that the claimant would not have to repay benefits, it is highly unlikely an lowa Workforce Development representative would utter such comments.

On August 13, 2022, Iowa Workforce Development mailed an Overpayment Statement to the claimant demanding repayment of the \$222.00 overpayment.

On September 28, 2022, the claimant completed and transmitted an online appeal from the July 4, 2022 (reference 04) overpayment decision. The Appeals Bureau received the appeal on September 28, 2022 and also treated it as an appeal from the July 22, 2022 (reference 02) disgualification decision.

REASONING AND CONCLUSIONS OF LAW:

Iowa Code section 96.6(2) provides:

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant. The representative shall promptly examine the claim and any protest, take the initiative to ascertain relevant information concerning the claim, and, on the basis of the facts found by the representative, shall determine whether or not the claim is valid, the week with respect to which benefits shall commence, the weekly benefit amount payable and its maximum duration, and whether any disqualification shall be imposed. The claimant has the burden of proving that the claimant meets the basic eligibility conditions of section 96.4. The employer has the burden of proving that the claimant is disqualified for benefits pursuant to section 96.5, except as provided by this subsection. The claimant has the initial burden to produce evidence showing that the claimant is not disqualified for benefits in cases involving section 96.5, subsections 10 and 11, and has the burden of proving that a voluntary guit pursuant to section 96.5, subsection 1, was for good cause attributable to the employer and that the claimant is not disqualified for benefits in cases involving section 96.5, subsection 1, paragraphs "a" through "h". Unless the claimant or other interested party, after notification or within ten calendar days after notification was mailed to the

claimant's last known address, files an appeal from the decision, the decision is final and benefits shall be paid or denied in accordance with the decision. If an administrative law judge affirms a decision of the representative, or the appeal board affirms a decision of the administrative law judge allowing benefits, the benefits shall be paid regardless of any appeal which is thereafter taken, but if the decision is finally reversed, no employer's account shall be charged with benefits so paid and this relief from charges shall apply to both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

The ten-day deadline for appeal begins to run on the date Workforce Development mails the decision to the parties. The "decision date" found in the upper right-hand portion of the Agency representative's decision, unless otherwise corrected immediately below that entry, is presumptive evidence of the date of mailing. *Gaskins v. Unempl. Comp. Bd. of Rev.*, 429 A.2d 138 (Pa. Comm. 1981); *Johnson v. Board of Adjustment*, 239 N.W.2d 873, 92 A.L.R.3d 304 (lowa 1976).

An appeal submitted by mail is deemed filed on the date it is mailed as shown by the postmark or in the absence of a postmark the postage meter mark of the envelope in which it was received, or if not postmarked or postage meter marked or if the mark is illegible, on the date entered on the document as the date of completion. See Iowa Administrative Code rule 871-24.35(1)(a). See also *Messina v. IDJS*, 341 N.W.2d 52 (Iowa 1983). An appeal submitted by any other means is deemed filed on the date it is received by the Unemployment Insurance Division of Iowa Workforce Development. See Iowa Administrative Code rule 871-24.35(1)(b).

The evidence in the record establishes that more than ten calendar days elapsed between the mailing date and the date this appeal was filed. The lowa Supreme Court has declared that there is a mandatory duty to file appeals from representatives' decisions within the time allotted by statute, and that the administrative law judge has no authority to change the decision of a representative if a timely appeal is not filed. Franklin v. IDJS, 277 N.W.2d 877, 881 (lowa 1979). Compliance with appeal notice provisions is jurisdictional unless the facts of a case show that the notice was invalid. Beardslee v. IDJS, 276 N.W.2d 373, 377 (lowa 1979); see also In re Appeal of Elliott, 319 N.W.2d 244, 247 (Iowa 1982). One question in this case thus becomes whether the appellant was deprived of a reasonable opportunity to assert an appeal in IESC, fashion. Hendren v. 217 N.W.2d 255 (lowa 1974): timely Smith v. IESC, 212 N.W.2d 471, 472 (lowa 1973).

No submission shall be considered timely if the delay in filing was unreasonable, as determined by the division after considering the circumstances in the case. See Iowa Administrative Code rule 871-24.35(2)(c).

The evidence in the record establishes an untimely appeal from the July 22, 2022 (reference 02) decision. The evidence establishes that the claimant received the reference 02 decision in a timely manner, had a reasonable opportunity to file an appeal by the appeal deadline, but unreasonably delayed filing the appeal to September 28, 2022. The late filing of the appeal was not attributable to the Iowa Workforce Development error or misinformation or delay or other action of the United States Postal Service. There is not good cause to treat the late appeal as a timely appeal. See Iowa Administrative Code rule 871-24.35(2). Because the appeal was untimely, the administrative law judge lacks jurisdiction to disturb the decision from which the appellant appeals in the present matter. See *Beardslee v. IDJS*, 276 N.W.2d 373 (lowa 1979) and *Franklin v. IDJS*, 277 N.W.2d 877 (lowa 1979).

DECISION:

The claimant's appeal from the July 22, 2022 (reference 02) decision was untimely. The decision that denied benefits effective July 3, 2022, based on the deputy's conclusion the claimant was not partially unemployed within the meaning of the law remains in effect.

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
