## STATEMENT OF THE CASE:

On August 23, 2023, the employer filed an appeal from the Statement of Charges that Iowa Workforce Development mailed on August 9, 2023. The Statement of Charges included a charge for benefits paid to the above-named claimant for benefits paid during the second quarter of 2023. After due notice was issued, a hearing was held on September 12, 2023. The claimant did not comply with the hearing notice instructions to call the designated toll-free number at the time of the hearing and did not participate. Steve Volle represented the employer. Exhibits 1 through 4 were received into evidence. The administrative law judge took official notice of the following agency administrative records: The May 24, 2023 SIDES notice of claim, the June 5, 2023 SIDES protest, DBRO, WAGEA, NMRO, and the August 9, 2023 Statement of Charges.

# ISSUES:

Whether the employer's protest of the claim for benefits was timely. Whether the employer filed a timely appeal from the Statement of Charges. Whether the Statement of Charges is correct.

## FINDINGS OF FACT:

Having reviewed the evidence in the record, the administrative law judge finds:

The claimant established an original claim for benefits that was effective May 21, 2023. The base period consists of the four quarters of 2022. This employer is the sole base period employer.

The employer had elected to receive electronic notice of claims via SIDES. On May 24, 2023, lowa Workforce Development issued a notice of claim to the employer via SIDES and provided a June 5, 2023 deadline for the employer's response. The employer received the notice on May 24, 2023. On June 5, 2023, the employer submitted a protest via SIDES. The employer referenced a January 27, 2023 separation date in the SIDES protest and characterized the

separation as a voluntary quit. Despite the protest, IWD did not schedule a fact-finding interview or enter a decision regarding the January 27, 2023 separation.

On August 9, 2023, IWD mailed a Statement of Charges to the employer that included a \$1,955.00 charge to the employer's account for benefits paid to the claimant during the quarter that ended June 30, 2023.

On August 23, 2023, the employer faxed an appeal of the Statement of Charges to the Appeals Bureau. The Appeals Bureau received the appeal on August 23, 2023.

# REASONING AND CONCLUSIONS OF LAW:

Iowa Code section 96.6(2) provides, in pertinent part:

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant.

Another portion of this same Code section dealing with timeliness of an appeal from a representative's decision states that such an appeal must be filed within ten days after notification of that decision was mailed. In addressing an issue of timeliness of an appeal under that portion of this Code section, the lowa Supreme Court held that this statute prescribing the time for notice of appeal clearly limits the time to do so, and that compliance with the appeal notice provision is mandatory and jurisdictional. *Beardslee v. IDJS*, 276 N.W.2d 373 (lowa 1979). The administrative law judge considers the reasoning and holding of the court to be controlling on this portion of that same lowa Code section which deals with a time limit in which to file a protest after notification of the filing of the claim has been mailed.

Iowa Administrative Code Rule 871-24.8(2)(a) and (b) provide as follows:

- (2) Responding by employing units to a notice of the filing of an initial claim or a request for wage and separation information and protesting the payment of benefits.
- a. The employing unit which receives a Form 65-5317, Notice of Claim, or a Form 68-0221, Request for Wage and Separation Information, must, within ten days of the date of the notice or request, submit to the department wage or separation information that affects the individual's rights to benefits, including any facts which disclose that the individual separated from employment voluntarily and without good cause attributable to the employer or was discharged for misconduct in connection with employment.
- b. The employing unit may protest the payment of benefits if the protest is postmarked within ten days of the date of the notice of the filing of an initial claim. In the event that the tenth day falls on a Saturday, Sunday or holiday, the protest period is extended to the next working day of the department. If the employing unit has filed a timely report of facts that might adversely affect the individual's benefit rights, the report shall be considered as a protest to the payment of benefits.

Iowa Administrative Code Rule 871-24.35(1) provides:

Date of submission and extension of time for payments and notices.

- (1) Except as otherwise provided by statute or by division rule, any payment, appeal, application, request, notice, objection, petition, report or other information or document submitted to the division shall be considered received by and filed with the division:
- a. If transmitted via the United States Postal Service on the date it is mailed as shown by the postmark, or in the absence of a postmark the postage meter mark of the envelope in which it is received; or if not postmarked or postage meter marked or if the mark is illegible, on the date entered on the document as the date of completion.
- b. If transmitted via the State Identification Data Exchange System (SIDES), maintained by the United States Department of Labor, on the date it was submitted to SIDES.
- c. If transmitted by any means other than those outlined in paragraphs 24.35(1)"a" and "b", on the date it is received by the division.

Iowa Administrative Code Rule 871-24.35(2) provides:

Date of submission and extension of time for payments and notices.

- (2) The submission of any payment, appeal, application, request, notice, objection, petition, report or other information or document not within the specified statutory or regulatory period shall be considered timely if it is established to the satisfaction of the division that the delay in submission was due to division error or misinformation or to delay or other action of the United States postal service.
- a. For submission that is not within the statutory or regulatory period to be considered timely, the interested party must submit a written explanation setting forth the circumstances of the delay.
- b. The division shall designate personnel who are to decide whether an extension of time shall be granted.
- c. No submission shall be considered timely if the delay in filing was unreasonable, as determined by the department after considering the circumstances in the case.
- d. If submission is not considered timely, although the interested party contends that the delay was due to division error or misinformation or delay or other action of the United States postal service, the division shall issue an appealable decision to the interested party.

Iowa Code section 96.7(2)(a)(6) provides:

- 2. Contribution rates based on benefit experience.
- a. (6) Within forty days after the close of each calendar quarter, the department shall notify each employer of the amount of benefits charged to the employer's account during that quarter. The notification shall show the name of each individual to whom benefits were paid, the individual's social security number, and the amount of benefits paid to the individual. An employer which has not been notified as provided in section 96.6, subsection 2, of the allowance of benefits to an individual, may within thirty days after the date of mailing of the

notification appeal to the department for a hearing to determine the eligibility of the individual to receive benefits. The appeal shall be referred to an administrative law judge for hearing and the employer and the individual shall receive notice of the time and place of the hearing.

Iowa Admin. Code rule 871-26.4(3) provides:

Notwithstanding the provisions of subrule 26.4(2), a contributory employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 30 days from the mailing date of the quarterly statement of benefit charges.

The employer filed a timely protest on June 5, 2023. Though the August 9, 2023 Statement of Charges was not the employer's first knowledge of the claim, the employer filed a timely challenge to the Statement of Charges. Based on the timely protest, this matter will be remanded to Iowa Workforce Development Benefits Bureau for a fact-finding interview and decision regarding the January 27, 2023 separation that the employer characterizes as a voluntary quit. The charge to the employer's account remains in place pending the remand and entry of decision regarding the separation.

## **DECISION:**

The employer filed a timely protest on June 5, 2023. This matter is MODIFIED in favor of the employer/appellant to reflect the timely protest. This matter will be remanded to lowa Workforce Development Benefits Bureau for a fact-finding interview and decision regarding the January 27, 2023 separation that the employer characterizes as a voluntary quit. The charge to the employer's account remains in place pending the remand and entry of decision regarding the separation.

## **REMAND:**

This matter is REMANDED to Iowa Workforce Development Benefits Bureau for a fact-finding interview and decision regarding the January 27, 2023 separation that the employer characterizes as a voluntary quit.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

## AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf.

**Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.

2.
