#### **DECISION**

#### STATEMENT OF THE CASE:

The issue of timeliness was raised when the Employer filed a faxed appeal on August 5, 2021, 13 days beyond the statutory deadline of July 28, 2021. The reason for the delay was because the Employer never received the Notice of Decision in the mail. For this reason, we find good cause has been established for the late appeal, and the board shall consider it to be timely.

## FINDINGS OF FACT:

The notice of hearing in this matter was mailed July 8, 2021. The notice set a hearing for July 23, 2021. The Employer did not appear for or participate in the hearing. The reason the Employer did not appear is because he did not receive the Notice of Hearing. The Employer did not know the hearing was taking place.

### REASONING AND CONCLUSIONS OF LAW:

Iowa Code section 10A.601(4) (2019) provides:

4. Appeal board review. The appeal board may on its own motion affirm, modify, or set aside any decision of an administrative law judge on the basis of the evidence previously submitted in such case, or direct the taking of additional evidence, or may permit any of the parties to such decision to initiate further appeals before it. The appeal board shall permit such further appeal by any of the parties interested in a decision of an administrative law judge and by the representative whose decision has been overruled or modified by the administrative law judge. The appeal board shall review the case pursuant to rules adopted by the appeal board. The appeal board shall promptly notify the interested parties of its findings and decision.

Here the Employer did not participate in the hearing through no fault of the Employer. The Employer did not participate because he did not receive the Notice of Hearing and did not know that a hearing was taking place. For this reason, the matter will be remanded for another hearing before an administrative law judge. **DECISION:** 

The decision of the administrative law judge dated August 5, 2021 is not vacated and remains in force unless and until the Department makes a differing determination pursuant to this remand. This matter is remanded to an administrative law judge in the Workforce Development Center, Appeals Section. The administrative law judge shall conduct a hearing following due notice. After the hearing, the administrative law judge shall issue a decision which provides the parties appeal rights.
