STATEMENT OF THE CASE:

On July 14, 2023, Judyann MacDonald (clamant) filed a late appeal from the May 26, 2023 (reference 02) decision that denied benefits for the period beginning April 23, 2023, based on the deputy's conclusion the claimant requested and was granted a leave of absence, was voluntarily unemployed, and was not available for work within the meaning of the law. After due notice was issued, a hearing was held on August 1, 2023. Claimant participated. Alice Rose Thatch of Corporate Cost Control, Inc. represented the employer. Employer witness Renicia Haywood was available for the hearing but was not called to testify. Exhibit A, the online appeal, was received into evidence. The administrative law judge took official notice of the following Agency administrative records: the reference 01 through 04 decisions, DBRO, KCCO, KFFV and WAGE-A.

ISSUE:

Whether the appeal was timely. Whether there is good cause to treat the appeal as timely.

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds:

Judyann MacDonald (claimant) established an original claim for benefits that was effective April 23, 2023. At that time, the claimant provided lowa Workforce a Cedar Falls mailing address. The mailing address was for the hotel room in which the claimant resided until the end of May 2023. The claimant became homeless toward the end of May 2023. The claimant elected to continue to have her mail directed to the same Cedar Falls address and would collect her mail from the hotel once or twice a week.

On May 26, 2023, Iowa Workforce Development mailed the May 26, 2023 (reference 02) decision to the claimant's Cedar Falls last-known address of record. The reference 02 decision denied benefits for the period beginning April 23, 2023, based on the deputy's conclusion the claimant requested and was granted a leave of absence from her Hy-Vee employment, was voluntarily unemployed, and was not available for work within the meaning of the law. The

reference 02 decision stated the decision would become final unless an appeal was postmarked by June 5, 2023 or was received by the Appeals Section by that date. The United States Postal Service delivered the reference 02 decision to the claimant's address of record in a timely manner, prior to the deadline for appeal. The claimant collected the correspondence from the Cedar Falls address of record and reviewed the reference 02 decision at the end of May or beginning of June 2023, prior to the deadline for appeal. The claimant erroneously concluded that her claim for benefits pertained only to a different employer. The claimant elected not to file an appeal from the reference 02 decision by the appeal deadline.

On or about June 3, 2023, the claimant commenced residing at an address in Waterloo. The c claimant remained at that address for a couple weeks. The claimant did not update her mailing address with lowa Workforce Development or the United States Postal Service in connection with this temporary residence in Waterloo. The claimant elected to continue to have her mail directed to the Cedar Falls address.

On June 22, 2023, Iowa Workforce Development mailed to the claimant the June 22, 2023 (reference 01) decision concerning the claimant and employer J&P Hospitality Management, L.L.C. The reference 03 decision was favorable to the claimant and allowed benefits, provided the claimant met all other eligibility requirements. The claimant thereafter elected to further pursue unemployment insurance benefits.

On or about July 14, 2023, the claimant spoke with IWD staff who told the claimant she would need to file an appeal from the May 26, 2023 (reference 02) decision pertaining to employment with Hy-Vee if she wished to pursue unemployment insurance benefits. In the appeal, the claimant provided a Waterloo address as her new address of record. This was the first time the claimant provided an updated address.

On July 14, 2023, the claimant completed and transmitted an online appeal from the reference 02 decision. The Appeals Bureau received the appeal on July 14, 2023.

The claimant reopened her unemployment claim during the week that started July 16, 2023.

REASONING AND CONCLUSIONS OF LAW:

Iowa Code section 96.6(2) provides:

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant. The representative shall promptly examine the claim and any protest, take the initiative to ascertain relevant information concerning the claim, and, on the basis of the facts found by the representative, shall determine whether or not the claim is valid, the week with respect to which benefits shall commence, the weekly benefit amount payable and its maximum duration, and whether any disqualification shall be imposed. The claimant has the burden of proving that the claimant meets the basic eligibility conditions of section 96.4. The employer has the burden of proving that the claimant is disqualified for benefits pursuant to section 96.5, except as provided by this subsection. The claimant has the initial burden to produce evidence showing that the claimant is not disqualified for benefits in cases involving section 96.5, subsections 10 and 11, and has the burden of proving that a voluntary quit pursuant to section 96.5, subsection 1, was for good cause attributable to the employer and that the claimant is not disqualified for benefits in cases involving section 96.5,

subsection 1, paragraphs "a" through "h". Unless the claimant or other interested party, after notification or within ten calendar days after notification was mailed to the claimant's last known address, files an appeal from the decision, the decision is final and benefits shall be paid or denied in accordance with the decision. If an administrative law judge affirms a decision of the representative, or the appeal board affirms a decision of the administrative law judge allowing benefits, the benefits shall be paid regardless of any appeal which is thereafter taken, but if the decision is finally reversed, no employer's account shall be charged with benefits so paid and this relief from charges shall apply to both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

The ten-day deadline for appeal begins to run on the date Workforce Development mails the decision to the parties. The "decision date" found in the upper right-hand portion of the Agency representative's decision, unless otherwise corrected immediately below that entry, is presumptive evidence of the date of mailing. *Gaskins v. Unempl. Comp. Bd. of Rev.*, 429 A.2d 138 (Pa. Comm. 1981); *Johnson v. Board of Adjustment*, 239 N.W.2d 873, 92 A.L.R.3d 304 (lowa 1976).

An appeal submitted by mail is deemed filed on the date it is mailed as shown by the postmark or in the absence of a postmark the postage meter mark of the envelope in which it was received, or if not postmarked or postage meter marked or if the mark is illegible, on the date entered on the document as the date of completion. See Iowa Administrative Code rule 871-24.35(1)(a). See also *Messina v. IDJS*, 341 N.W.2d 52 (Iowa 1983). An appeal submitted by any other means is deemed filed on the date it is received by the Unemployment Insurance Division of Iowa Workforce Development. See Iowa Administrative Code rule 871-24.35(1)(b).

The evidence in the record establishes that more than ten calendar days elapsed between the mailing date and the date this appeal was filed. The lowa Supreme Court has declared that there is a mandatory duty to file appeals from representatives' decisions within the time allotted by statute, and that the administrative law judge has no authority to change the decision of a representative if a timely appeal is not filed. Franklin v. IDJS, 277 N.W.2d 877, 881 (Iowa 1979). Compliance with appeal notice provisions is jurisdictional unless the facts of a case show that the notice was invalid. Beardslee v. IDJS, 276 N.W.2d 373, 377 (lowa 1979); see also In re Appeal of Elliott, 319 N.W.2d 244, 247 (Iowa 1982). One guestion in this case thus becomes whether the appellant was deprived of a reasonable opportunity to assert an appeal in timely fashion. Hendren v. IESC, 217 N.W.2d 255 (lowa 1974); Smith v. IESC, 212 N.W.2d 471, 472 (lowa 1973).

No submission shall be considered timely if the delay in filing was unreasonable, as determined by the division after considering the circumstances in the case. See Iowa Administrative Code rule 871-24.35(2)(c).

The evidence in the record establishes an untimely appeal from the May 26, 2023 (reference 02) decision concerning the claimant and Hy-Vee and the benefit period beginning April 23, 2023. The evidence establishes that the United States Postal Service delivered the decision to the address of record in a timely manner and that the claimant received the reference 02 decision in a timely manner. The claimant had a reasonable opportunity to file an appeal by the appeal deadline, but unreasonably delayed filing the appeal to July 14, 2023. The late filing of the appeal was not attributable to the lowa Workforce Development error or misinformation or delay or other action of the United States Postal Service. There is not good cause to treat the late appeal as a timely appeal. See lowa Administrative Code rule 871-24.35(2). Because the appeal was untimely, the administrative law judge lacks jurisdiction

to disturb the decision from which the appellant appeals in the present matter. See *Beardslee v. IDJS*, 276 N.W.2d 373 (lowa 1979) and *Franklin v. IDJS*, 277 N.W.2d 877 (lowa 1979).

DECISION:

The claimant's appeal from the May 26, 2023 (reference 02) decision was untimely. The decision that denied benefits for the period beginning April 23, 2023, based on the deputy's conclusion the claimant requested and was granted a leave of absence, was voluntarily unemployed, and was not available for work within the meaning of the law, remains in effect. The reference 02 decision applies only to the period of April 23, 2023 through July 15, 2023. Neither the reference 02 decision nor the present decision prevents the claimant, the employer or IWD from addressing the availability issues for the period beginning July 16, 2023 in connection with the reopened claim.

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.

2. Si nadie presenta una apelación de la decisión del juez ante la Junta de Apelaciones Laborales dentro de los quince (15) días, la decisión se convierte en acción final de la agencia y usted tiene la opción de presentar una petición de revisión judicial en el Tribunal de Distrito dentro de los treinta (30) días después de que la decisión adquiera firmeza.
