## STATEMENT OF THE CASE:

On September 15, 2022, Lisa Bolan (claimant) filed a late appeal from the March 11, 2022 (reference 02) decision that held the claimant was overpaid \$2,539.00 in benefits for 27 weeks between December 20, 2020 and June 19, 2021, due to a failure to report or incorrect report of wages from American Post Works. The reference 02 decision further indicated that a claimant was subject to a 15 percent penalty and an additional administrative penalty due to the claimant misrepresenting her wages. After due notice was issued, a hearing was held on October 18, 2022. Claimant participated. Debbie Rumbaugh represented lowa Workforce Development Investigation & Recovery Unit. The hearing in this matter was consolidated with the hearing in Appeal Number 22A-Ul-17276-JT-T. Exhibit 1-1 and Exhibit A, the claimant's mailed appeal, were received into evidence. The administrative law judge took official notice of the following Agency administrative records: the March 11, 2022 (reference 02) decision, and the March 11, 2022 (reference 04) decision. The administrative law judge left the hearing record open for the limited purpose of allowing the claimant the opportunity to submit purported documentary proof of an appeal filed earlier than September 15, 2022. The claimant instead provided a statement indication she could not locate such proof. The claimant's late submission was received into evidenced as Exhibit B.

## ISSUE:

Whether the appeal was timely. Whether there is good cause to treat the appeal as timely.

## **FINDINGS OF FACT:**

Having reviewed all of the evidence in the record, the administrative law judge finds:

On March 11, 2022, lowa Workforce Development mailed two decisions to the claimant. The reference 02 decision held the claimant was overpaid \$2,539.00 in benefits for 27 weeks between December 20, 2020 and June 19, 2021, due to a failure to report or incorrect report of wages from American Post Works. The reference 02 decision further indicated that a claimant was subject to a 15 percent penalty and an additional administrative penalty due to the claimant

misrepresenting her wages. The reference 04 decision held the claimant was not eligible for unemployment insurance benefits due to an outstanding fraud overpayment balance. Each decision stated the decision would become final unless an appeal was postmarked by March 21, 2022 or was received by the Appeals Section by that date. The claimant received the reference 02 and reference 04 decisions in a timely manner, prior to the deadline for appeal. On March 16, 2022, the claimant sent an email message to an lowa Workforce Development investigator indicating she wanted to "formally dispute the allegation of fraud." The claimant asked what she needed to do next. The investigator promptly responded that if the claimant disagreed with the decision(s), the claimant had the right to appeal, pursuant to the appeal rights set forth on the decisions. The claimant did not take steps to file an appeal from the decision by the appeal deadline. On September 15, 2022, the claimant drafted and mailed an appeal. The mailed appeal is postmarked September 15, 2022.

## **REASONING AND CONCLUSIONS OF LAW:**

lowa Code section 96.6(2) provides:

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant. The representative shall promptly examine the claim and any protest, take the initiative to ascertain relevant information concerning the claim, and, on the basis of the facts found by the representative, shall determine whether or not the claim is valid, the week with respect to which benefits shall commence, the weekly benefit amount payable and its maximum duration, and whether any disqualification shall be imposed. The claimant has the burden of proving that the claimant meets the basic eligibility conditions of section 96.4. The employer has the burden of proving that the claimant is disqualified for benefits pursuant to section 96.5, except as provided by this subsection. The claimant has the initial burden to produce evidence showing that the claimant is not disqualified for benefits in cases involving section 96.5, subsections 10 and 11, and has the burden of proving that a voluntary guit pursuant to section 96.5, subsection 1, was for good cause attributable to the employer and that the claimant is not disqualified for benefits in cases involving section 96.5, subsection 1, paragraphs "a" through "h". Unless the claimant or other interested party. after notification or within ten calendar days after notification was mailed to the claimant's last known address, files an appeal from the decision, the decision is final and benefits shall be paid or denied in accordance with the decision. If an administrative law judge affirms a decision of the representative, or the appeal board affirms a decision of the administrative law judge allowing benefits, the benefits shall be paid regardless of any appeal which is thereafter taken, but if the decision is finally reversed, no employer's account shall be charged with benefits so paid and this relief from charges shall apply to both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

The ten-day deadline for appeal begins to run on the date Workforce Development mails the decision to the parties. The "decision date" found in the upper right-hand portion of the Agency representative's decision, unless otherwise corrected immediately below that entry, is presumptive evidence of the date of mailing. *Gaskins v. Unempl. Comp. Bd. of Rev.*, 429 A.2d 138 (Pa. Comm. 1981); *Johnson v. Board of Adjustment*, 239 N.W.2d 873, 92 A.L.R.3d 304 (lowa 1976).

An appeal submitted by mail is deemed filed on the date it is mailed as shown by the postmark or in the absence of a postmark the postage meter mark of the envelope in which it was received, or if not postmarked or postage meter marked or if the mark is illegible, on the date entered on the document as the date of completion. See lowa Administrative Code rule 871-24.35(1)(a). See also *Messina v. IDJS*, 341 N.W.2d 52 (lowa 1983). An appeal submitted by any other means is deemed filed on the date it is received by the Unemployment Insurance Division of lowa Workforce Development. See lowa Administrative Code rule 871-24.35(1)(b).

The evidence in the record establishes that more than ten calendar days elapsed between the mailing date and the date this appeal was filed. The lowa Supreme Court has declared that there is a mandatory duty to file appeals from representatives' decisions within the time allotted by statute, and that the administrative law judge has no authority to change the decision of a representative if a timely appeal is not filed. Franklin v. IDJS, 277 N.W.2d 877, 881 (lowa 1979). Compliance with appeal notice provisions is jurisdictional unless the facts of a case show that the notice was invalid. Beardslee v. IDJS, 276 N.W.2d 373, 377 (lowa 1979); see also In re Appeal of Elliott, 319 N.W.2d 244, 247 (lowa 1982). One guestion in this case thus becomes whether the appellant was deprived of a reasonable opportunity to assert an appeal in а timely fashion. Hendren v. IESC. 217 N.W.2d 255 (lowa 1974); Smith v. IESC, 212 N.W.2d 471, 472 (lowa 1973).

No submission shall be considered timely if the delay in filing was unreasonable, as determined by the division after considering the circumstances in the case. See lowa Administrative Code rule 871-24.35(2)(c).

The evidence in the record establishes an untimely appeal from the March 11, 2022 (reference 02) decision. The evidence establishes that the claimant received the reference 02 decision in a timely manner, had a reasonable opportunity to file an appeal by the appeal deadline, but unreasonably delayed filing the appeal to September 15, 2022. The late filing of the appeal was not attributable to the lowa Workforce Development error or misinformation or delay or other action of the United States Postal Service. There is not good cause to treat the late appeal as a timely appeal. See lowa Administrative Code rule 871-24.35(2). Because the appeal was untimely, the administrative law judge lacks jurisdiction to disturb the decision from which the appellant appeals in the present matter. See *Beardslee v. IDJS*, 276 N.W.2d 373 (lowa 1979) and *Franklin v. IDJS*, 277 N.W.2d 877 (lowa 1979).

# **DECISION:**

The claimant's appeal from the March 11, 2022 (reference 02) decision was untimely. The decision remains in effect.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

### AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at low a Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf.

**Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
