#### STATEMENT OF THE CASE:

The claimant filed a timely appeal from the July 23, 2018, (reference 07), unemployment insurance decision that denied benefits because of a failure to report as directed. After due notice was issued, a telephone conference hearing was set for August 10, 2018. Claimant participated.

#### ISSUE:

Did the claimant fail to report as directed or offer a good cause reason for failure to do so?

#### FINDINGS OF FACT:

Having heard the testimony and having examined the evidence in the record, the administrative law judge finds: On July 16, 2018, a notice was mailed to the claimant to be available for a call from IWD on July 20, 2018, at 10:40 A.M. about her availability for work the week ending July 7, 2018. The notice was received in the mail, but was misplaced in the claimant's home. Therefore, claimant was unaware of the phone call. The fact finder left a voice message instructing claimant to return the call prior to 11:00 a.m., but claimant did not receive the voice message until after 11:00 a.m. on July 20, 2018. A decision was issued on July 23, 2018, denying claimant benefits based on her failure to report as directed. Claimant came into the agency and filed an appeal on July 25, 2018.

#### **REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes the underlying issue was the result of a reporting error, and the claimant failed to report as directed until July 25, 2018.

Iowa Code section 96.4(3) provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.19, subsection 38, paragraph "b", unnumbered paragraph (1), or temporarily unemployed as defined in section 96.19, subsection 38, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3 are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

## Iowa Admin. Code r. 871-24.2(1)e provides:

- e. In order to maintain continuing eligibility for benefits during any continuous period of unemployment, an individual shall report as directed to do so by an authorized representative of the department. If the individual has moved to another locality, the individual may register and report in person at a workforce development center at the time previously specified for the reporting.
- (1) An individual who files a weekly continued claim will have the benefit payment automatically deposited weekly on a debit card specified by the department.
- (2) The department retains the ultimate authority to choose the method of reporting and payment.

### Iowa Admin. Code r. 871-24.23(11) provides:

Availability disqualifications. The following are reasons for a claimant being disqualified for being unavailable for work.

(11) Failure to report as directed to workforce development in response to the notice which was mailed to the claimant will result in the claimant being deemed not to meet the availability requirements.

Here, claimant failed to report as directed without good cause until July 25, 2018. Therefore, benefits are allowed effective July 25, 2018.

## **DECISION:**

The July 23, 2018, (reference 07) unemployment insurance decision is modified in favor of appellant. The claimant failed to report as directed without good cause until July 25, 2018. The underlying issue was the result of a reporting error. Benefits are allowed effective July 25, 2018, provided claimant is otherwise eligible.
