Section 96.3-7 - Recovery of Overpayment of Benefits

STATEMENT OF THE CASE:

The claimant appealed an unemployment insurance decision dated August 19, 2004, reference 02, that concluded that she had been overpaid \$405.00 in unemployment insurance benefits. A telephone hearing was held on September 20, 2004. The claimant participated in the hearing.

FINDINGS OF FACT:

The claimant filed a new claim for unemployment insurance benefits with an effective date of July 11, 2004. The claimant filed for and received a total of \$270.00 in unemployment insurance benefits for the weeks between July 25 and August 7, 2004.

The unemployment insurance decision that disqualified the claimant from receiving unemployment insurance benefits has been modified in a decision of the administrative law

judge in appeal 04A-UI-09288-SWT to change the effective date of the disqualification as July 25, 2004.

REASONING AND CONCLUSIONS OF LAW:

The issue in this case is whether the claimant was overpaid unemployment insurance benefits.

Iowa Code section 96.3-7 provides:

7. Recovery of overpayment of benefits. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

Since the claimant is disqualified from receiving unemployment insurance benefits effective July 25, 2004, the claimant was overpaid \$270.00 in unemployment insurance benefits.

DECISION:

The unemployment insurance decision dated August 19, 2004, reference 02, is modified in favor of the claimant. The claimant was overpaid \$270.00 in unemployment insurance benefits, which must be repaid.
