# APPEAL 23A-UI-10469-CS-T

# STATEMENT OF THE CASE:

On November 6, 2023, the claimant/appellant filed an appeal from the November 2, 2023 (reference 04) unemployment insurance decision that found claimant was not eligible for unemployment benefits effective October 29, 2023, because the claimant failed to report as directed. The claimant was properly notified of the hearing. A telephone hearing was held on November 28, 2023. The hearing was held with appeals 23A-UI-10467-CS-T and 23A-UI-10468-CS-T and the record was combined into one. The claimant participated personally. The administrative law judge took official notice of the claimant's unemployment insurance benefits records.

### **ISSUES:**

- I. Was the claimant able to work and available for work effective October 29, 2023?
- II. Did the claimant fail to report as directed by a department representative?

# FINDINGS OF FACT:

Having heard the testimony and having examined the evidence in the record, the administrative law judge finds: A notice was mailed to the claimant to be available for a call from Iowa Workforce Development (IWD) on report to IWD on October 30, 2023. IWD called claimant and left a message. Claimant received the message and immediately called back. IWD again called claimant and again left a message. Claimant again returned the phone call and left a message. Claimant was having problems with her phone and IWD's phone called would not ring so she could answer the calls. Claimant contacted her phone and internet provider and they subsequently discovered and fixed the claimant's internet and phone issues. IWD issued a decision on November 2, 2023 (reference 04), that denied benefits effective October 29, 2023 due to claimant's failure to participate in the phone call.

Claimant is not under a doctor's restriction restricting her from working. Claimant is working a part-time job.

# **REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes the underlying issue was established a good cause reason for having failed to report as directed.

Iowa Code § 96.4(3) provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.19, subsection 38, paragraph "b", unnumbered paragraph (1), or temporarily unemployed as defined in section 96.19, subsection 38, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3 are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

Iowa Admin. Code r. 871-24.2(1)e provides, in relevant part:

e. In order to maintain continuing eligibility for benefits during any continuous period of unemployment, an individual shall report as directed to do so by an authorized representative of the department. If the individual has moved to another locality, the individual may register and report in person at a workforce development center at the time previously specified for the reporting.

. . . .

(2) The department retains the ultimate authority to choose the method of reporting and payment.

Iowa Admin. Code r. 871-24.23(11) provides:

Availability disqualifications. The following are reasons for a claimant being disqualified for being unavailable for work.

(11) Failure to report as directed to workforce development in response to the notice which was mailed to the claimant will result in the claimant being deemed not to meet the availability requirements.

Claimant attempted to participate in the phone call with IWD. Both parties exchanged multiple phone calls and messages but due to claimant's phone issues the parties were not able to connect. The carrier subsequently fixed the phone and internet issues claimant was having. The claimant has established a good cause reason for failing to report as directed. Claimant is able and available for work. Benefits are allowed effective October 29, 2023, provided claimant is otherwise eligible.

# **DECISION:**

The November 2, 2023, reference 04, unemployment insurance decision is REVERSED. The claimant has established a good cause reason for failing to report as directed. Claimant is able and available for work. Benefits are allowed effective October 29, 2023, provided she is otherwise eligible.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

#### AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. **Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
