STATEMENT OF THE CASE

On January 14, 2013, Iowa Workforce Development (“IWD”) issued a decision, reference 01, finding Appellant/Claimant Cameron Corbett was ineligible to receive unemployment insurance benefits as of January 6, 2013 because he failed to report to a reemployment assessment interview on January 8, 2013. Corbett appealed.

IWD transferred the case to the Iowa Department of Inspections and Appeals, Division of Administrative Hearing and a contested case hearing is scheduled to be held on March 28, 2013. On March 25, 2014, my office received a withdrawal of the appeal from Corbett. IWD's rules allow an appellant to withdraw an appeal at any time prior to the issuance of a decision, with the approval of the administrative law judge.¹ The request to withdraw the appeal is granted.

DECISION

Corbett's request to withdraw the appeal is granted. This matter is deemed withdrawn.
