**STATEMENT OF THE CASE:**

Mary A Cahoon, the claimant/appellant, filed an appeal from the February 9, 2021 (reference 01) unemployment insurance decision that denied benefits. The parties were properly notified of the hearing. A telephone hearing was held on May 12, 2021, at 3:00 p.m. Ms. Cahoon participated and testified. Dennis Alcorn participated in the hearing on behalf of Ms. Cahoon. The employer did not register for the hearing and did not participate. Ms. Cahoon withdrew her appeal on the record.

**ISSUE:**

Should Ms. Cahoon's request to withdraw her appeal be granted?

**FINDINGS OF FACT:**

Ms. Cahoon requested to withdraw her appeal on the record during the hearing on May 12, 2021.

The Iowa Workforce Development decision dated March 6, 2021 concluded that Ms. Cahoon is eligible for Pandemic Unemployment Assistance (PUA) benefits effective October 11, 2020.

**REASONING AND CONCLUSIONS OF LAW:**

An appellant may submit a written request to withdraw an appeal at any time prior to the issuance of a decision. Iowa Admin. Code r. 871-26.8(1). An oral request must be tape-recorded by the presiding officer. *Id.*

Based on the available record in the appeal file, and in accordance with the applicable statutes and rules, Ms. Cahoon's request to withdraw her appeal should be approved.

**DECISION:**

Ms. Cahoon's request to withdraw her appeal of the February 9, 2021 (reference 01) unemployment insurance decision is approved. That decision shall stand and remain in full force and effect.
