STATEMENT OF THE CASE:

The claimant/appellant filed an appeal from the June 6, 2022 (reference 01) unemployment insurance decision that denied the claimant from receipt of benefits due to her voluntarily quitting work. The parties were properly notified of the hearing. A telephone hearing was held on July 22, 2022. The claimant participated personally. Attorney Nadine Stille represented the claimant. The employer did not participate. The administrative law judge took official notice of the claimant's unemployment insurance benefits records.

ISSUE:

Is the separation from employment disqualifying?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant was employed full-time as a customer service advocate beginning July 21, 2021. On April 30, 2022, the claimant voluntarily quit the employment because she had obtained employment with Miller Pest, which was a full-time position that paid her a higher wage per hour. She worked at Miller Pest from May 2, 2022 until May 8, 2022, when she separated from employment. She earned \$19.00 per hour and worked approximately 53.00 for Miller Pest.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes as follows:

lowa Code section 96.5(1)a provides:

An individual shall be disqualified for benefits, regardless of the source of the individual's wage credits:

1. Voluntary quitting. If the individual has left work voluntarily without good cause attributable to the individual's employer, if so found by the department. But the individual shall not be disqualified if the department finds that:

a. The individual left employment in good faith for the sole purpose of accepting other or better employment, which the individual did accept, and the individual performed services in the new employment. Benefits relating to wage credits earned with the employer that the individual has left shall be charged to the unemployment compensation fund. This paragraph applies to both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

A voluntary quitting means discontinuing the employment because the employee no longer desires to remain in the relationship of an employee with the employer and requires an intention to terminate the employment. *Wills v. Emp't Appeal Bd.*, 447 N.W. 2d 137, 138 (lowa 1989). A voluntary leaving of employment requires an intention to terminate the employment relationship accompanied by an overt act of carrying out that intention. *Local Lodge #1426 v. Wilson Trailer*, 289 N.W.2d 608, 612 (lowa 1980); *Peck v. Emp't Appeal Bd.*, 492 N.W.2d 438 (lowa Ct. App. 1992). Claimant has the burden of proving that the voluntary leaving was for good cause attributable to the employer, or that another exception to the rule exists. lowa Code § 96.6(2).

Iowa Admin. Code r. 871-23.43(5) provides:

(5) Sole purpose. The claimant shall be eligible for benefits even though the claimant voluntarily quit if the claimant left for the sole purpose of accepting an offer of other or better employment, which the claimant did accept, and from which the claimant is separated, before or after having started the new employment. No charge shall accrue to the account of the former voluntarily quit employer.

In this case, the claimant left work with this employer for the sole purpose of accepting an offer of other or better employment, which she did accept and from which she later became separated from. As such, the separation from employment with this employer is not disqualifying and the employer shall not be charged for benefits paid. Benefits are allowed, provided the claimant remained otherwise eligible.

DECISION:

The June 6, 2022 (reference 01) unemployment insurance decision is modified in favor of the claimant. The separation from employment with this employer is not disqualifying because the claimant voluntarily quit for the sole purpose of accepting other or better employment. Benefits are allowed, provided the claimant is otherwise eligible. The employer's account shall not be charged for benefits paid pursuant to lowa Admin. Code r. 871-23.43(5).

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at low a Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
