## STATEMENT OF THE CASE:

On May 27, 2019, the claimant filed an appeal from the May 20, 2020, (reference 01) unemployment insurance decision that denied benefits based on claimant's availability for work. The parties were properly notified about the hearing. A telephone hearing was held on June 15, 2020. Claimant participated personally through an interpreter with CTS Language Link. Employer participated through payroll/hr supervisor Laura Roney. Claimant's Exhibit A was received.

# ISSUE:

Is the claimant able to and available for work?

## FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant began working for employer on July 24, 2019. Claimant last worked as a part-time packager.

Claimant did not work from April 8, 2020, through May 23, 2020.

Claimant had symptoms of COVID 19 and family members who tested positive for COVID 19. On April 18, 2020, claimant was tested for COVID 19. Even though claimant's test results came back negative, his doctor advised him to stay off work until the symptoms went away.

Claimant's doctor gave claimant a letter stating that if the symptoms went away, he can go back to work.

Claimant returned to work on May 24, 2020.

## REASONING AND CONCLUSIONS OF LAW:

Iowa Code section 96.4(3) provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.19, subsection 38, paragraph "b", unnumbered paragraph (1), or temporarily unemployed as defined in section 96.19, subsection 38, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3 are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

Iowa Admin. Code r. 871-24.23(35) provides:

Availability disqualifications. The following are reasons for a claimant being disqualified for being unavailable for work.

(35) Where the claimant is not able to work and is under the care of a medical practitioner and has not been released as being able to work.

In this case, claimant could not work from April 8 until May 24, 2020, due to illness. Claimant has not shown he was able to and available for work, and therefore is not eligible for regular, state-funded unemployment insurance benefits.

Even though claimant is not eligible for regular unemployment insurance benefits under state law, claimant may be eligible for federally funded unemployment insurance benefits under the Coronavirus Aid, Relief, and Economic Security Act ("Cares Act"), Public Law 116-136. Section 2102 of the CARES Act creates a new temporary federal program called Pandemic Unemployment Assistance (PUA) that in general provides up to 39 weeks of unemployment benefits. An individual receiving PUA benefits may also receive the \$600 weekly benefit amount (WBA) under the Federal Pandemic Unemployment Compensation (FPUC) program if he or she is eligible for such compensation for the week claimed. Claimant must apply for PUA, as noted in the instructions provided in the "Note to Claimant" below.

## **DECISION:**

The May 20, 2020, (reference 01) unemployment insurance decision is affirmed. The claimant was not able to and available for work during the relevant time period. Regular unemployment insurance benefits funded by the state of Iowa are denied. Claimant <u>may</u> be eligible for federally-funded benefits called "PUA," but must follow the instructions below in order to qualify.
