**STATEMENT OF THE CASE:**

The claimant/appellant filed an appeal from the March 21, 2017 (reference 02) unemployment insurance decision that found claimant was not eligible for unemployment benefits because he was mailed a note to report to Iowa Workforce Development and failed to report. Benefits were denied as of March 12, 2017. The claimant was properly notified of the hearing. A telephone hearing was held on April 18, 2017. The claimant, Arlen D. Rost, participated personally. Claimant's Exhibit A was admitted. The issue appealed was resolved administratively prior to the hearing in the appellant's favor (see reference 03 unemployment insurance decision).

**ISSUES:**

Is the claimant able to work and available for work effective March 12, 2017?  
Should the unemployment insurance decision be affirmed?

**FINDINGS OF FACT:**

Having reviewed all of the evidence in the record, the administrative law judge finds: The decision appealed has been resolved in favor of the appellant by the reference 03 unemployment insurance decision. Claimant was able to and available for work effective March 12, 2017. Claimant did report as directed by completing the required form as requested on March 12, 2017. See Exhibit A.

**REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes the unemployment insurance decision should be reversed.

Iowa Code section 96.4(3) provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.19,

subsection 38, paragraph "b", unnumbered paragraph (1), or temporarily unemployed as defined in section 96.19, subsection 38, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3 are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

Iowa Admin. Code r. 871-24.2(1)e provides:

e. In order to maintain continuing eligibility for benefits during any continuous period of unemployment, an individual shall report as directed to do so by an authorized representative of the department. If the individual has moved to another locality, the individual may register and report in person at a workforce development center at the time previously specified for the reporting.

The method of reporting shall be weekly if a voice response continued claim is filed, unless otherwise directed by an authorized representative of the department. An individual who files a voice response continued claim will have the benefit payment automatically deposited weekly in the individual's account at a financial institution or be paid by the mailing of a warrant on a biweekly basis.

In order for an individual to receive payment by direct deposit, the individual must provide the department with the appropriate bank routing code number and a checking or savings account number.

The department retains the ultimate authority to choose the method of reporting and payment.

Iowa Admin. Code r. 871-24.23(11) provides:

Availability disqualifications. The following are reasons for a claimant being disqualified for being unavailable for work.

(11) Failure to report as directed to workforce development in response to the notice which was mailed to the claimant will result in the claimant being deemed not to meet the availability requirements.

Since the decision appealed has been resolved in favor of the appellant, the original unemployment insurance decision bearing reference 02 is reversed. Claimant is able to and available for work effective March 12, 2017.

**DECISION:**

The March 21, 2017 (reference 02) unemployment insurance decision is reversed. Benefits are allowed, provided claimant is otherwise eligible.
