Section 96.3-7 - Recovery of Benefit Overpayment

STATEMENT OF THE CASE:

The claimant appealed the April 16, 2004, reference 04, decision that concluded the claimant was overpaid unemployment insurance benefits in the amount of \$808.00 as a result of a disqualification decision. A telephone hearing was held on August 25, 2004, pursuant to due notice. The claimant did participate through the interpretation of Zijo Suceska and was represented by Teresa Jones, Legal Assistant.

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: The overpayment issue in this case was created by a disqualification decision that has now been affirmed.

REASONING AND CONCLUSIONS OF LAW:

Iowa Code Section 96.3-7 provides:

7. Recovery of overpayment of benefits. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

The administrative law judge concludes that the claimant has been overpaid unemployment insurance benefits in the amount of \$808.00, pursuant to Iowa Code Section 96.3-7, as the disqualification decision that created the overpayment decision has now been affirmed.

DECISION:

The April 16, 2004, reference 04 decision is affirmed. The claimant has been overpaid unemployment insurance benefits in the amount of \$808.00.
