STATEMENT OF THE CASE:

The claimant filed a timely appeal from a representative's unemployment insurance decision dated November 20, 2014, (reference 01), that concluded the claimant/appellant was not eligible for unemployment insurance benefits after a separation from employment with McSoifer's (McDonalds). Notices of hearing were mailed to the parties' last-known addresses of record for a telephone hearing to be held at 11:00 a.m. on December 18, 2014. Prior to the hearing, the claimant provided a telephone number at which she could be reached for the hearing. She answered her phone and was participating in the hearing until the employer began testifying. Shortly after the employer began speaking about an incident at the beginning of the hearing the claimant's telephone line disconnected. The administrative law judge called the claimant back three times but after ringing a few times the claimant's phone went to voice mail and the administrative law judge left a message with her name and the phone number for the claimant to call back to participate. The claimant had not called the Appeals Bureau back as of 4:30 p.m. Friday, December 19, 2014.

ISSUE:

The issue is whether the underlying decision should be affirmed and the appeal should be effectively dismissed based upon the claimant/appellant's failure to participate in the hearing.

FINDINGS OF FACT:

The parties were properly notified of the scheduled hearing on this appeal. A Notice of Appeal and Hearing was mailed to both parties on December 5, 2014. The evidence establishes the claimant/appellant received the hearing notice prior to the hearing scheduled on December 18, 2014.

The front page of the hearing notices states: "The judge will not call you on the day of the hearing if you have not registered your phone number with the Appeals Bureau in **Des Moines, lowa as instructed below.**" This information can be found on both the front and the back of the hearing notice. The hearing notice instructions further advise the parties, "If you do not participate in the hearing because you do not register for the hearing, register late, or

cannot be reached at the number you provided when the judge calls for the hearing, the appeal may be dismissed or decided based on other available evidence."

The claimant/appellant answered her telephone at the date and time of the scheduled hearing, remained on the phone through the opening statement, was sworn, and was listening to the beginning of the employer's testimony when she disconnected. She did not answer the three times the administrative law judge called her back and did not contact the Appeals Bureau prior to 4:30 p.m., Friday, December 19, 2014. She did not participate in the hearing or request a postponement of the hearing as required by the hearing notice.

The representative's decision concluded that the claimant was not eligible for unemployment insurance benefits.

REASONING AND CONCLUSIONS OF LAW:

The Iowa Administrative Procedure Act at Iowa Code § 17A.12(3) provides that if a party fails to appear or participate in a hearing after proper service of notice, the judge may enter a default decision or proceed with the hearing and make a decision in the absence of the party. Likewise, Agency rule 871 IAC 26.14(7) provides that if the appealing party has not responded to a notice of telephone hearing by providing the Appeals Bureau with the names and telephone numbers of the persons who are participating in the hearing by the scheduled starting time of the hearing or is not available at the telephone number provided, the judge may decide the appealing party is in default and dismiss the appeal as provided in Iowa Code § 17A.12(3).

This rule does not provide exceptions for good intentions and/or a party contacting the Appeals Bureau within a reasonable amount of time after the hearing is scheduled. It can be assumed an appellant intends to participate in the hearing simply by the fact an appeal is filed, but their responsibility does not end there. All parties are required to follow the specific written instructions printed on the hearing notice. Due process requires notice and an opportunity to be heard, both of which were provided to the parties.

If the claimant/appellant responds to the notice of hearing after the record has been closed, the administrative law judge shall not take the evidence of the late party. Instead, the administrative law judge shall inquire ex parte as to why the party was late in responding to the notice of hearing. For good cause shown, the record shall be reopened and cause further notice of hearing to be issued. The record <u>shall not be reopened without a finding of good cause</u> for the party's late response to the notice of hearing. 871 IAC 26.14(7)b. Furthermore, the rule states that failure to read or follow the hearing notice instructions shall not constitute good cause. 871 IAC 26.14(7)c.

The claimant/appellant appealed the unemployment insurance decision but failed to participate in the scheduled appeal hearing. The claimant/appellant has therefore defaulted on her appeal pursuant to Iowa Code § 17A.12(3) and 871 IAC 26.14(7), and the representative's decision remains in force and effect.

If the appellant disagrees with this decision, a written request to reopen the record must be made to the administrative law judge within 15 days after the mailing date of this decision. The written request should be mailed to the administrative law judge at the address listed at the end of this decision and must explain the emergency or other good cause that prevented the appellant from participating in the hearing at the scheduled time. The appellant also has the option to appeal the decision directly to the Employment Appeal Board, whose address is listed at the beginning of the decision.

DECISION:

The representative's unemployment insurance decision dated November 20, 2014, (reference 01), is affirmed. The decision denying benefits to the claimant remains in effect.
