STATEMENT OF THE CASE:

Claimant filed an appeal from the July 13, 2021 (reference 04) unemployment insurance decision that found claimant was overpaid Pandemic Emergency Unemployment Compensation (PEUC) benefits. Claimant was properly notified of the hearing. A telephone hearing was held on September 29, 2021, at 8:10 a.m. Claimant participated. No exhibits were admitted. Official notice was taken of the administrative record. The legal citation on the hearing notice was incorrect; claimant waived ten days' notice of the correct citation.

ISSUE:

Whether claimant is overpaid PEUC benefits.

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant has received PEUC in the gross amount of \$1,296.00 for the four-week period between July 26, 2020 and August 22, 2020.

On August 26, 2020, Iowa Workforce Development (IWD) issued a decision (reference 01) that denied claimant UI benefits effective May 2, 2020. That decision has been affirmed (see appeal 21A-UI-00923-LJ-T).

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes:

PL 116-136 Sec 2107 provides in pertinent part:

PANDEMIC EMERGENCY UNEMPLOYMENT COMPENSATION.

(a) FEDERAL-STATE AGREEMENTS. –

. . .

- (2) PROVISIONS OF AGREEMENT. —Any agreement under paragraph (1) shall provide that the State agency of the State will make payments of pandemic emergency unemployment compensation to individuals who—
- (A) have exhausted all rights to regular compensation under the State law or under Federal law with respect to a benefit year (excluding any benefit year that ended before July 1, 2019);
- (B) have no rights to regular compensation with respect to a week under such law or any other State unemployment compensation law or to compensation under any other Federal law;
- (C) are not receiving compensation with respect to such week under the unemployment compensation law of Canada; and
 - (D) are able to work, available to work, and actively seeking work.

. . .

(e) FRAUD AND OVERPAYMENTS.—

. . .

- (2) REPAYMENT.—In the case of individuals who have received amounts of pandemic emergency unemployment compensation under this section to which they were not entitled, the State shall require such individuals to repay the amounts of such pandemic emergency unemployment compensation to the State agency, except that the State agency may waive such repayment if it determines that—
- (A) the payment of such pandemic emergency unemployment compensation was without fault on the part of any such individual; and
 - (B) such repayment would be contrary to equity and good conscience.

The decision that denied claimant UI benefits remains in effect. Because claimant is not eligible for UI, she is not eligible for PEUC. Therefore, claimant has received PEUC benefits to which claimant was not entitled. The administrative law judge concludes that claimant has been overpaid PEUC benefits in the amount outlined in the findings of fact above. Those benefits must be recovered in accordance with lowa law.

DECISION:

The July 13, 2021 (reference 04) unemployment insurance decision is affirmed. Claimant has been overpaid PEUC benefits in the amount of \$1,296.00, which must be repaid.
