Section 96.3(7) – Overpayment of Benefits

STATEMENT OF THE CASE:

Holly Briggs filed a timely appeal from the July 3, 2006, reference 03, decision that concluded she had been overpaid unemployment insurance benefits in the amount of \$104.00 for the week ending June 24, 2006 based on her employer's timely designation of the period to which vacation pay was to be applied. After due notice was issued, a hearing was held on July 25, 2006. Ms. Briggs participated in the hearing. The administrative law judge took official notice of the Agency's administrative file. The hearing was consolidated with the hearing in appeal number 06A-UI-07075-JTT and the administrative law judge hereby takes official notice of the decision entered in that matter.

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: The overpayment issue in this case was created by a disqualification decision that has now been affirmed. See appeal number 06A-UI-07075-JTT.

REASONING AND CONCLUSIONS OF LAW:

Iowa Code section 96.3-7 provides:

7. Recovery of overpayment of benefits. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

The administrative law judge concludes that the claimant, Ms. Briggs, has been overpaid unemployment insurance benefits in the amount of \$104.00 for the benefit week ending June 24, 2006, pursuant to Iowa Code section 96.3(7) because the disqualification decision that created the overpayment decision has now been affirmed. However, the Agency has already recovered the overpayment by subtracting the overpayment amount from Ms. Briggs' benefits for the week that ended July 1, 2006.

DECISION:

The Agency representative's July 3, 2006, reference 03, overpayment decision is affirmed. The claimant was overpaid unemployment insurance benefits in the amount of \$104.00 for the benefit week that ended June 24, 2006. However, the Agency has already recovered the overpayment by subtracting the overpayment amount from Ms. Briggs' benefits for the week that ended July 1, 2006.
