871 IAC 26.8(1) – Withdrawal of Appeal

STATEMENT OF THE CASE:

The claimant filed a timely appeal from an unemployment insurance decision dated April 16, 2004, reference 02, which denied unemployment insurance benefits to him. Due notice was issued for a telephone hearing to be held May 11, 2004. At the time of the hearing, the claimant requested that the appeal be withdrawn.

FINDINGS OF FACT:

Having examined all matters of record, the administrative law judge finds: The claimant, the appellant in this matter, has requested that the appeal be withdrawn.

REASONING AND CONCLUSIONS OF LAW:

A rule found 871 IAC 26.8(1) allows the administrative law judge to grant an appellant's request for the withdrawal of its appeal. A review of all matters of record persuades the administrative law judge that it is appropriate to allow the withdrawal of this appeal.

DECISION:

The unemployment insurance decision dated April 16, 2004, reference 02, remains in effect. The claimant is ineligible for unemployment insurance benefits until he establishes that he is medically able to work.
