#### STATEMENT OF THE CASE:

Claimant/appellant, Matthew Rensberger, filed an appeal from the March 15, 2022, (reference 02) unemployment insurance decision that determined claimant was overpaid \$600.00 in FPUC benefits for the 2-week period between 02/21/21 and 03/06/2021, due to claimant failing to report and/or incorrectly reporting wages earned with Siouxland Lawn Care, LLC. After proper notice, a telephone hearing was conducted on May 12, 2022. Claimant participated personally. Employer, Siouxland Lawn Care, LLC, did not participate. The following hearings were held together as part of a consolidated hearing: Appeals 22A-UI-07875-DH-T, and 22A-UI-07877-DH-T. Judicial notice was taken of the administrative records, including his email wanting to withdraw his appeal in 22A-UI-078770-DH-T scheduled for May 12, 2022, advising that given the lateness of his email, he would call and confirm on the record. Appellant withdrew his appeal on the record.

#### ISSUE:

Whether the request to withdraw the appeal should be granted.

### **FINDINGS OF FACT:**

The appellant requested to withdraw the appeal in both 22A-UI-07875-DH-T, and 22A-UI-07877-DH-T on the record during the hearing on May 12, 2022.

### **REASONING AND CONCLUSIONS OF LAW:**

An appellant may submit a written request to withdraw an appeal at any time prior to the issuance of a decision. Iowa Admin. Code r. 871-26.8(1). An oral request must be tape-recorded by the presiding officer. *Id.* 

Based on the available record in the appeal file, and in accordance with the applicable statutes and rules, the request of the appealing party to withdraw the appeal should be approved.

## **DECISION:**

The appealing party's request to withdraw the appeal of the March 15, 2022, (reference 02) unemployment insurance decision is approved. That decision shall stand and remain in full force and effect.
