STATEMENT OF THE CASE:

On August 29, 2024, Beckstrom Construction, Inc. (employer) filed an appeal from the statement of charges dated August 9, 2024, reference 01, for the second quarter of 2024. A hearing was held on September 18, 2024, pursuant to due notice. William Dennis (claimant) did not participate. Employer participated through general manager Jason Boyle. The administrative law judge took official notice of the administrative record, including the SIDES system notice of claim and employer response, the above-mentioned reference 01 statement of charges, and the August 29, 2024, appeal.

ISSUES:

Was the employer's protest timely?
Was the employer's appeal from the statement of charges timely?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant filed an initial claim for benefits effective August 6, 2023, following a separation from employment on August 10, 2023. The weekly benefit amount is \$626.00. A notice of claim was emailed to the employer from Iowa Workforce Development (IWD) on August 10, 2023 via the SIDES system. Employer received the notice of claim and responded to the notice on the deadline to do so, August 21, 2023, noting that claimant was separated due to completion of the job. Claimant filed an additional claim for benefits effective March 17, 2024, and filed weekly continuing claims. On August 9, 2024, a statement of charges was mailed to the employer for the second quarter of 2024. The employer filed its appeal of that statement of charges on August 29, 2024.

The administrative record indicates that between claimant's separation from employment and the time at which he filed his additional claim for benefits, he earned at least \$6,260.00, or ten times the weekly benefit amount.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes employer has not appropriately filed an appeal of the statement of charges.

Iowa Code section 96.6(2) provides, in pertinent part:

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant.

Iowa Code section 96.7(2)a(6) provides:

2. Contribution rates based on benefit experience.

a. (6) Within forty days after the close of each calendar quarter, the department shall notify each employer of the amount of benefits charged to the employer's account during that quarter. The notification shall show the name of each individual to whom benefits were paid, the individual's social security number, and the amount of benefits paid to the individual. *An employer which has not been notified as provided in section 96.6, subsection 2, of the allowance of benefits to an individual, may within thirty days after the date of mailing of the notification appeal to the department for a hearing to determine the eligibility of the individual to receive benefits.* The appeal shall be referred to an administrative law judge for hearing and the employer and the individual shall receive notice of the time and place of the hearing. [Emphasis added.]

Iowa Admin. Code r. 871-26.4 provides, in relevant part:

2. An appeal from an initial decision concerning the allowance or denial of benefits shall be filed, by mail, facsimile, or e-mail, online, or in person, not later than ten calendar days, as determined by the postmark or the date stamp after the decision was mailed to the party at its last-known address and shall state the following:

- a. The name, address and social security number of the claimant;
- b. A reference to the decision from which appeal is taken; and,
- c. The grounds upon which the appeal is based.

3. *Notwithstanding the provisions of subrule 26.4(2), a contributory employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 30 days from the mailing date of the quarterly statement of benefit charges.*

4. Also notwithstanding the provisions of subrule 26.4(2), a reimbursable employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 15 days of the mailing date of the quarterly billing of benefit charges.

An employer may appeal a statement of charges when it has not received prior notice of a valid claim for benefits. Here, employer received notice of claimant's filing for unemployment insurance benefits through the initial notice of claim. The appropriate remedy is not an appeal of the statement of charges. The record developed in this hearing illustrates that the employer has received notice of the claimant's filing of a valid claim for benefits, and it may not appeal the quarterly statement of charges.


The matter of whether claimant has earned at least ten times his weekly benefit amount since the separation will be remanded to the Benefits Bureau for a determination.

DECISION:

The August 9, 2024, reference 01, statement of charges for the second quarter of 2024 is affirmed.

REMAND:

The issue of whether claimant has requalified for benefits since the separation, but before filing the additional claim for benefits, is remanded to the Benefits Bureau of Iowa Workforce Development for an initial investigation and determination.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at <https://www.legis.iowa.gov/docs/code/17A.19.pdf> or by contacting the District Court Clerk of Court <https://www.iowacourts.gov/iowa-courts/court-directory/>.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.

2.
