STATEMENT OF THE CASE

On August 1, 2011, Iowa Workforce Development (“IWD”) issued two decisions reference 02 and 03 determining that the appellant, Angela Odean, was ineligible to receive unemployment insurance benefits as of July 24, 2011, until she completed reemployment services. On August 11, 2011, Ms. Odean filed the present appeals of these decisions.

IWD transferred the case to the Iowa Department of Inspections and Appeals, Division of Administrative Hearings, on September 2, 2011 to schedule a contested case hearing. Notices of hearing issued on September 7, 2011, and hearings in these matters were set for September 30, 2011, at 1:00 p.m.

On September 29, 2011, the appellant contacted the Reemployment Services Coordinator and stated that she no longer wished to appeal these decisions. The appellant's benefits have been reinstated. IWD's rules allow an appellant to withdraw an appeal at any time prior to the issuance of a decision, with the approval of the administrative law judge. 871 IAC 26.8(1). The request to withdraw these appeals is granted.

DECISION

Angela Odean's request to withdraw these appeals is granted. The matters are deemed WITHDRAWN, and the September 30, 2011, hearing is vacated.
