### STATEMENT OF THE CASE:

On August 22, 2023, the employer filed an appeal from the Statement of Charges that Iowa Workforce Development mailed to the employer on August 9, 2023. The Statement of Charges included a charge for benefits paid to the above claimant during the second calendar quarter of 2023 that ended June 30, 2023. After due notice was issued, a hearing was held on September 13, 2023. The claimant did not comply with the hearing notice instructions to call the designated toll-free number at the time of the hearing and did not participate. Colleen McGuinty represented the employer. Exhibits 1, 2 and 3 were received into evidence. The administrative law judge took official notice of the following agency administrative records, the notice of claim, the Statement of Charges mailed August 9, 2023, DBRO, WAGEA and NMRO.

## **ISSUES:**

Whether the employer's protest of the claim for benefits was timely. Whether the employer filed a timely appeal from the Statement of Charges. Whether the Statement of Charges is correct.

# **FINDINGS OF FACT:**

Having reviewed the evidence in the record, the administrative law judge finds:

The claimant established an original claim for benefits that was effective April 16, 2023.

On April 21, 2023, Iowa Workforce Development mailed a notice of claim concerning the above claimant to the employer's address of record. The notice of claim contained a warning that any protest must be postmarked, faxed or returned by the due date set forth on the notice, which was May 1, 2023. The notice of claim was received at the employer's address of record in a timely manner, prior to the deadline for protest. On April 24, 2023, the employer faxed a protest to lowa Workforce Development. The employer had provided a copy of the notice of claim and documentation of successful transmission of a protest to a designated protest fax number on April 24, 2023. The weight of the evidence indicates that IWD Benefits Bureau lost the one-

page protest document. The Benefits Bureau did not schedule a fact-finding interview or enter a determination in response to the employer's protest.

On August 9, 2023, Iowa Workforce Development mailed a Statement of Charges to the employer's address of record. The Statement of Charges included a charge for benefits paid to the above claimant during the second calendar quarter of 2023 that ended June 30, 2023. The employer received the Statement of Charges in a timely manner. On August 22, 2023, the employer faxed an appeal of the Statement of Charges on August 22, 2023. The weight of the evidence indicates the Appeals Bureau received the appeal on August 22, 2023, but erroneously docketed the appeal as received on August 23, 2023.

## **REASONING AND CONCLUSIONS OF LAW:**

lowa Code section 96.6(2) provides, in pertinent part:

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant.

Another portion of this same Code section dealing with timeliness of an appeal from a representative's decision states that such an appeal must be filed within ten days after notification of that decision was mailed. In addressing an issue of timeliness of an appeal under that portion of this Code section, the lowa Supreme Court held that this statute prescribing the time for notice of appeal clearly limits the time to do so, and that compliance with the appeal notice provision is mandatory and jurisdictional. *Beardslee v. IDJS*, 276 N.W.2d 373 (lowa 1979). The administrative law judge considers the reasoning and holding of the court to be controlling on this portion of that same lowa Code section which deals with a time limit in which to file a protest after notification of the filing of the claim has been mailed.

Iowa Administrative Code Rule 871-24.8(2)(a) and (b) provide as follows:

- (2) Responding by employing units to a notice of the filing of an initial claim or a request for wage and separation information and protesting the payment of benefits.
- a. The employing unit which receives a Form 65-5317, Notice of Claim, or a Form 68-0221, Request for Wage and Separation Information, must, within ten days of the date of the notice or request, submit to the department wage or separation information that affects the individual's rights to benefits, including any facts which disclose that the individual separated from employment voluntarily and without good cause attributable to the employer or was discharged for misconduct in connection with employment.
- b. The employing unit may protest the payment of benefits if the protest is postmarked within ten days of the date of the notice of the filing of an initial claim. In the event that the tenth day falls on a Saturday, Sunday or holiday, the protest period is extended to the next working day of the department. If the employing unit has filed a timely report of facts that might adversely affect the individual's benefit rights, the report shall be considered as a protest to the payment of benefits.

Iowa Administrative Code Rule 871-24.35(1) provides:

Date of submission and extension of time for payments and notices.

- (1) Except as otherwise provided by statute or by division rule, any payment, appeal, application, request, notice, objection, petition, report or other information or document submitted to the division shall be considered received by and filed with the division:
- a. If transmitted via the United States Postal Service on the date it is mailed as shown by the postmark, or in the absence of a postmark the postage meter mark of the envelope in which it is received; or if not postmarked or postage meter marked or if the mark is illegible, on the date entered on the document as the date of completion.
- b. If transmitted via the State Identification Data Exchange System (SIDES), maintained by the United States Department of Labor, on the date it was submitted to SIDES.
- c. If transmitted by any means other than those outlined in paragraphs 24.35(1)"a" and "b", on the date it is received by the division.

Iowa Administrative Code Rule 871-24.35(2) provides:

Date of submission and extension of time for payments and notices.

- (2) The submission of any payment, appeal, application, request, notice, objection, petition, report or other information or document not within the specified statutory or regulatory period shall be considered timely if it is established to the satisfaction of the division that the delay in submission was due to division error or misinformation or to delay or other action of the United States postal service.
- a. For submission that is not within the statutory or regulatory period to be considered timely, the interested party must submit a written explanation setting forth the circumstances of the delay.
- b. The division shall designate personnel who are to decide whether an extension of time shall be granted.
- c. No submission shall be considered timely if the delay in filing was unreasonable, as determined by the department after considering the circumstances in the case.
- d. If submission is not considered timely, although the interested party contends that the delay was due to division error or misinformation or delay or other action of the United States postal service, the division shall issue an appealable decision to the interested party.

Iowa Code section 96.7(2)(a)(6) provides:

- 2. Contribution rates based on benefit experience.
- a. (6) Within forty days after the close of each calendar quarter, the department shall notify each employer of the amount of benefits charged to the employer's account during that quarter. The notification shall show the name of each individual to whom benefits were paid, the individual's social security number, and the amount of benefits paid to the individual. An employer which has not been notified as provided in section 96.6, subsection 2, of the allowance of benefits to an individual, may within thirty days after the date of mailing of the notification appeal to the department for a hearing to determine

the eligibility of the individual to receive benefits. The appeal shall be referred to an administrative law judge for hearing and the employer and the individual shall receive notice of the time and place of the hearing.

Iowa Admin. Code rule 871-26.4(3) provides:

Notwithstanding the provisions of subrule 26.4(2), a contributory employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 30 days from the mailing date of the quarterly statement of benefit charges.

The employer filed a timely protest on April 24, 2023, but IWD failed to docket and process the timely protest. In light of the timely protest, this matter will be remanded to lowa Workforce Development Benefits Bureau a fact-finding interview and decision concerning the February 5, 2023 separation that the employer characterizes as a voluntary quit to accept other employment. The charge to the employer's account remains in effect pending the remand a decision regarding the separation.

# **DECISION:**

The employer filed a timely protest on April 24, 2023. The matter is MODIFIED in favor of the employer/appellant to reflect the timely protest. This matter will be remanded to lowa Workforce Development Benefits Bureau for a fact-finding interview and decision concerning the February 5, 2023 separation that the employer characterizes as a voluntary quit to accept other employment. The charge to the employer's account remains in effect pending the remand a decision regarding the separation.

# **REMAND:**

This matter is REMANDED to Iowa Workforce Development Benefits Bureau for a fact-finding interview and decision concerning the February 5, 2023 separation that the employer characterizes as a voluntary quit to accept other employment.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

### AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at lowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf.

**Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
