STATEMENT OF THE CASE:

On May 4, 2022, Jamaal Suell (claimant) filed a late appeal from the April 12, 2021, (reference 01) decision that disqualified the claimant for benefits and that held the employer's account would not be charged for benefits, based on the deputy's conclusion that the claimant was discharged on December 31, 2020, for violation of a known company rule. After due notice was issued, a hearing was held on June 17, 2022. Claimant participated. The employer did not comply with the hearing notice instructions to call the toll-free number at the time of the hearing and did not participate. The hearing in this matter was consolidated with the hearing in Appeal Number 22A-UI-11431-JT-T. Exhibit A, the faxed appeal form, was received into evidence. The administrative law judge took official notice of the following Agency administrative records: the reference 01 and 05 decisions, DBRO, KPYX, and KCCO.

ISSUE:

Whether the appeal was timely. Whether there is good cause to treat the appeal as timely.

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds:

On April 12, 2021, Iowa Workforce Development mailed the April 12, 2021 (reference 01) decision to the claimant's last-known address of record. The address of record is the claimant's mother's home, where the claimant usually resides. The reference 01 decision disqualified the claimant for benefits, based on the deputy's conclusion that the claimant was discharged on December 31, 2020 from his employment with Walmart for violation of a known company rule. The reference 01 decision stated the decision would become final unless an appeal was postmarked by April 22, 2021 or was received by the Appeals Section by that date. The decision stated that if the deadline for appeal fell on a Saturday, Sunday or legal holiday, the deadline would be extended to the next working day. The reference 01 decision was delivered to the address of record in a timely manner, prior to the deadline for appeal. The claimant may have been away from the residence at the time the decision was delivered. The claimant's mother alerted the claimant to receipt of the Iowa Workforce Development Correspondence.

The claimant did not have his mother open or review the correspondence. The claimant never opened or reviewed the correspondence. The claimant did not take any steps to file an appeal from the reference 01 decision by the April 22, 2021 appeal deadline or at any time prior to May 4, 2022. The claimant discontinued his unemployment insurance claim after making a weekly claim on April 16, 2021 for the week that ended April 10, 2021. The discontinuation of the claim occurred close in time to the mailing of the April 12, 2021 (reference 01) decision.

On April 22, 2022, Iowa Workforce Development mailed the April 22, 2022 (reference 05) decision to the claimant's Cedar Rapids address of record. The reference 05 decision held the claimant was overpaid \$1,363.00 in regular benefits and \$1,800.00 in Federal Pandemic Unemployment Compensation (FPUC) for the six weeks between February 14, 2021 and March 27, 2021. The reference 05 stated the overpayment determinations were based on the reference 01 decision regarding the claimant's discharge from Walmart. The reference 05 decision stated the decision would become final unless an appeal was postmarked by May 2, 2022 or was received by the Appeals Bureau by that date. The claimant received the reference 05 decision in a timely manner, prior to the deadline for appeal. The claimant did not take steps to file an appeal from the reference 05 decision by the May 2, 2022 appeal deadline.

On May 4, 2022, the claimant went the Cedar Rapids IowaWORKS Center, completed an appeal form regarding the April 22, 2022 (reference 05) decision, and provided the appeal form to the Center staff. The Center staff faxed the appeal to the Appeals Bureau. The Appeals Bureau received the appeal on May 4, 2022 and treated the late appeal from the overpayment decision as also a late appeal from the reference 01 disqualification decision.

REASONING AND CONCLUSIONS OF LAW:

Iowa Code section 96.6(2) provides:

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant. The representative shall promptly examine the claim and any protest, take the initiative to ascertain relevant information concerning the claim, and, on the basis of the facts found by the representative, shall determine whether or not the claim is valid, the week with respect to which benefits shall commence, the weekly benefit amount payable and its maximum duration, and whether any disqualification shall be imposed. The claimant has the burden of proving that the claimant meets the basic eligibility conditions of section 96.4. The employer has the burden of proving that the claimant is disqualified for benefits pursuant to section 96.5, except as provided by this subsection. The claimant has the initial burden to produce evidence showing that the claimant is not disqualified for benefits in cases involving section 96.5, subsections 10 and 11, and has the burden of proving that a voluntary quit pursuant to section 96.5, subsection 1, was for good cause attributable to the employer and that the claimant is not disqualified for benefits in cases involving section 96.5, subsection 1, paragraphs "a" through "h". Unless the claimant or other interested party, after notification or within ten calendar days after notification was mailed to the claimant's last known address, files an appeal from the decision, the decision is final and benefits shall be paid or denied in accordance with the decision. If an administrative law judge affirms a decision of the representative, or the appeal board affirms a decision of the administrative law judge allowing benefits, the benefits shall be paid regardless of any appeal which is thereafter taken, but if the decision is finally reversed, no employer's account shall be charged with benefits so paid and this relief from charges shall apply to

both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

The ten-day deadline for appeal begins to run on the date Workforce Development mails the decision to the parties. The "decision date" found in the upper right-hand portion of the Agency representative's decision, unless otherwise corrected immediately below that entry, is presumptive evidence of the date of mailing. *Gaskins v. Unempl. Comp. Bd. of Rev.*, 429 A.2d 138 (Pa. Comm. 1981); *Johnson v. Board of Adjustment*, 239 N.W.2d 873, 92 A.L.R.3d 304 (Iowa 1976).

An appeal submitted by mail is deemed filed on the date it is mailed as shown by the postmark or in the absence of a postmark the postage meter mark of the envelope in which it was received, or if not postmarked or postage meter marked or if the mark is illegible, on the date entered on the document as the date of completion. See Iowa Administrative Code rule 871-24.35(1)(a). See also *Messina v. IDJS*, 341 N.W.2d 52 (Iowa 1983). An appeal submitted by any other means is deemed filed on the date it is received by the Unemployment Insurance Division of Iowa Workforce Development. See Iowa Administrative Code rule 871-24.35(1)(b).

The evidence in the record establishes that more than ten calendar days elapsed between the mailing date and the date this appeal was filed. The Iowa Supreme Court has declared that there is a mandatory duty to file appeals from representatives' decisions within the time allotted by statute, and that the administrative law judge has no authority to change the decision of a representative if a timely appeal is not filed. *Franklin v. IDJS*, 277 N.W.2d 877, 881 (Iowa 1979). Compliance with appeal notice provisions is jurisdictional unless the facts of a case show that the notice was invalid. *Beardslee v. IDJS*, 276 N.W.2d 373, 377 (Iowa 1979); see also *In re Appeal of Elliott*, 319 N.W.2d 244, 247 (Iowa 1982). One question in this case thus becomes whether the appellant was deprived of a reasonable opportunity to assert an appeal in a timely fashion. *Hendren v. IESC*, 217 N.W.2d 255 (Iowa 1974); *Smith v. IESC*, 212 N.W.2d 471, 472 (Iowa 1973).

No submission shall be considered timely if the delay in filing was unreasonable, as determined by the division after considering the circumstances in the case. See Iowa Administrative Code rule 871-24.35(2)(c).

The evidence in the record establishes an untimely appeal from the April 12, 2021, (reference 01) decision. The evidence establishes that the decision was delivered to the claimant's address of record in a timely manner, that the claimant was aware of the correspondence but disregarded the correspondence, that the claimant did not take steps to file an appeal by the April 22, 2021 deadline and then unreasonably delayed filing the appeal until May 4, 2022. The late filing of the appeal was not attributable to the Iowa Workforce Development error or misinformation or delay or other action of the United States Postal Service. There is not good cause to treat the late appeal as a timely appeal. See Iowa Administrative Code rule 871-24.35(2). Because the appeal was untimely, administrative law judge lacks jurisdiction to disturb the decision from which the claimant appeals in the present matter. See *Beardslee v. IDJS*, 276 N.W.2d 373 (Iowa 1979) and *Franklin v. IDJS*, 277 N.W.2d 877 (Iowa 1979).

DECISION:

The claimant's appeal from the April 12, 2021, (reference 01) decision was untimely. The decision that disqualified the claimant for benefits and that held the employer's account would

not be charged for benefits, based on the deputy's conclusion that the claimant was discharged on December 31, 2020, for violation of a known company rule, remains in effect.

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at <https://www.legis.iowa.gov/docs/code/17A.19.pdf> or by contacting the District Court Clerk of Court <https://www.iowacourts.gov/iowa-courts/court-directory/>.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.

2.
