STATEMENT OF THE CASE:

The claimant appealed a representative's May 6, 2014 determination (reference 04) that held her ineligible to receive benefits as of March 30, 2014, because she did not report to a scheduled interview. A notice of hearing was mailed to the claimant's last-known address of record informing her that a telephone hearing would be held at 8:30 a.m. on May 29, 2014. A review of the Appeals Bureau's conference call system shows the claimant/appellant failed to respond to the hearing notice and provide a telephone number at which she could be reached for the hearing. The claimant did not participate in the hearing.

ISSUE:

Should the appeal be dismissed when the claimant/appellant does not participate in the hearing?

FINDINGS OF FACT:

The claimant was properly notified of the scheduled hearing on this appeal. The claimant/appellant failed to provide a telephone number at which she could be reached for the hearing. The claimant did not participate in the hearing or request a postponement of the hearing as required by the hearing notice.

The representative's May 6 determination held the claimant ineligible to receive benefits as of March 30, 2014, because she did not report for an interview as directed by a representative.

REASONING AND CONCLUSIONS OF LAW:

The Iowa Administrative Procedures Act at Iowa Code § 17A.12(3) provides that if a party fails to appear or participate in a hearing after proper service of notice, the judge may enter a default decision or proceed with the hearing and make a decision in the absence of the party. The

statute further states that if a party makes a timely request to vacate the decision and shows good cause for failing to appear, the judge shall vacate the decision and conduct another hearing.

The Agency rules at Iowa Admin. Code r. 871-26.14(7) provide that if the appealing party has not responded to a notice of telephone hearing by providing the appeals bureau with the names and telephone numbers of the persons who are participating in the hearing by the scheduled starting time of the hearing or is not available at the telephone number provided, the judge may decide the appealing party is in default and dismiss the appeal as provided in Iowa Code § 17A.12(3). The record may be reopened if the absent party makes a request to reopen the hearing and shows good cause for reopening the hearing. The rules further state that failure to read or follow the instructions on the notice of hearing is not good cause for reopening the record. Iowa Admin. Code r. 871-26.14(7)c.

The claimant/appellant appealed a May 6, 2014 determination, but failed to participate in the hearing. The claimant/appellant defaulted on her appeal. Based on Iowa Code § 17A.12(3) and Iowa Admin. Code r. 871-24.14(7), the determination remains in force and effect.

If the claimant/appellant disagrees with this decision, a request must be made to the administrative law judge that the hearing be reopened within 15 days after the mailing date of this decision. The written request should be mailed to the administrative law judge at the address listed at the end of this decision and must explain the emergency or other good cause that prevented the claimant/appellant from participating in the hearing at its scheduled time.

DECISION:

The representative's May 6, 2014 determination (reference 04) is affirmed. The claimant is not eligible to receive benefits as of March 30, 2014, because she did not report for an interview as directed by a Department representative. The claimant remains ineligible until she reopens her claim and establishes her eligibility to receive benefits.
