STATEMENT OF THE CASE:

Shannon Johnson, the claimant/appellant,¹ appealed the Iowa Workforce Development (IWD) June 27, 2023 (reference 01) unemployment insurance (UI) decision. IWD warned Ms. Johnson to engage in at least four reemployment activities, including at least three job applications each week, and keep a record because IWD concluded she had reported fewer than four reemployment activities for the week of June 18-24, 2023. The decision did not deny Ms. Johnson REGULAR (state) UI benefits. On September 14, 2023, the Iowa Department of Inspections, Appeals and Licensing (DIAL), UI Appeals Bureau mailed a notice of hearing Ms. Johnson for a telephone hearing scheduled for September 28, 2023.

The undersigned administrative law judge held a telephone hearing on September 28, 2023. Ms. Johnson participated in the hearing personally. The undersigned took official notice of the administrative record.

ISSUES:

Did Ms. Johnson appeal on time? Is the work search warning appropriate?

FINDINGS OF FACT:

Having reviewed the evidence in the record, the undersigned finds: IWD mailed the June 27, 2023 (reference 01) UI decision to Ms. Johnson at her correct address. The UI decision states that it becomes final unless an appeal is postmarked or received by the IWD Appeals Section by Friday, July 7, 2023. Ms. Johnson received the decision in the mail, but she doesn't remember when. At some point, Ms. Johnson threw away the papers she received from IWD because she was focused on applying for disability benefits.

In relevant part, on August 15, 2023, IWD mailed Ms. Johnson another UI decision. This decision, a reference 03 decision, denied Ms. Johnson REGULAR (state) UI benefits for the week of July 2-8, 2023 because IWD concluded that she did not meet the reemployment activities requirement for this week after IWD had warned her about the requirement. appeal deadline in this decision was Friday, August 25, 2023. Ms. Johnson received this decision in the mail, but she doesn't remember when. At some point, Ms. Johnson threw away the papers she received from IWD because she was focused on applying for disability benefits.

On September 7, 2023, IWD mailed Ms. Johnson another UI decision. This decision, a reference 04 decision, concluded that IWD overpaid Ms. Johnson REGULAR (state) UI benefits in the total gross amount of \$525.00 for the week of July 2-8, 2023 because the reference 03 decision denied her UI benefits for this week. The appeal deadline in this decision was Sunday, September 17, 2023. If the appeal deadline falls on a Saturday, Sunday, or legal holiday, it is extended to the next working day. So, the appeal deadline was extended to Monday, September 18, 2023. Ms. Johnson received this decision in the mail.

Ms. Johnson appealed via fax on September 12, 2023. The DIAL UI Appeals Bureau received the appeal the same day.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the undersigned concludes Ms. Johnson did not appeal the June 27, 2023 (reference 01) UI decision on time.

lowa Code § 96.6(2) provides, in relevant part: "[u]nless the claimant or other interested party, after notification or within ten calendar days after notification was mailed to the claimant's last known address, files an appeal from the decision, the decision is final and benefits shall be paid or denied in accordance with the decision."

Iowa Admin. Code r. 871-24.35(1) provides:

- 2. Except as otherwise provided by statute or by division rule, any payment, appeal, application, request, notice, objection, petition, report or other information or document submitted to the division shall be considered received by and filed with the division.
- (2) If transmitted via the United States Postal Service on the date it is mailed as shown by the postmark, or in the absence of a postmark the postage meter mark of the envelope in which it is received; or if not postmarked or postage meter marked or if the mark is illegible, on the date entered on the document as the date of completion.
- (b) If transmitted via the State Identification Date Exchange System (SIDES), maintained by the United States Department of Labor, on the date it was submitted to SIDES.
- (c) If transmitted by any means other than [United States Postal Service or the State Identification Data Exchange System (SIDES)], on the date it is received by the division.

Iowa Admin. Code r. 871-24.35(2) provides:

2. The submission of any payment, appeal, application, request, notice, objection, petition, report or other information or document not within the specified statutory or regulatory period shall be considered timely if it is established to the satisfaction of the division that the delay in submission was due to division error or misinformation or to delay or other action of the United States postal service.

The lowa Supreme Court has declared that there is a mandatory duty to file appeals from representatives' decisions within the time allotted by statute, and that the administrative law judge has no authority to change the decision of a representative if a timely appeal is not filed.² Compliance with appeal notice provisions is jurisdictional unless the facts of a case show that the notice was invalid.³

Ms. Johnson received the June 27, 2023 (reference 01) UI decision before the appeal deadline and, therefore, could have appealed by the deadline. The notice provision of the decision was valid. Ms. Johnson's delay in filing her appeal was not due to an error or misinformation from IWD or due to delay or other action of the United States Postal Service. Ms. Johnson has not established any other good cause reason for the delay in filing her appeal. Ms. Johnson did not appeal the June 27, 2023 (reference 01) UI decision on time and the undersigned lacks jurisdiction (authority) to decide the other issue in this matter.

DECISION:

Ms. Johnson did not appeal the June 27, 2023 (reference 01) UI decision on time. The June 27, 2023 (reference 01) UI decision is AFFIRMED.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at lowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf or by contacting the District Court Clerk of Court https://www.iowacourts.gov/iowa-courts/court-directory/.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
