STATEMENT OF THE CASE:

The claimant/appellant, Spencer Clouse, filed an appeal from the March 23, 2021 (reference 02) lowa Workforce Development ("IWD") unemployment insurance decision that allowed benefits. The parties were properly notified about the hearing. A telephone hearing was held on June 11, 2021. The hearing was held together with Appeals 21A-UI-08740-JC-T and 21A-UI-08744-JC-T. The claimant participated personally. The employer participated through Jessica Wade. At the time of hearing, claimant requested to withdraw the appeal. The request was recorded using the Appeals Bureau's conference call recording software.

ISSUE:

Should the request to withdraw the appeal be granted?

FINDINGS OF FACT:

The administrative law judge, having considered the evidence in the record, finds that: A request has been made by the appealing party to withdraw the appeal. The request has been recorded using the Appeals Bureau's conference call recording software.

REASONING AND CONCLUSIONS OF LAW:

Iowa Admin. Code r. 871-26.8(1) provides:

(1) An appeal may be withdrawn at any time prior to the issuance of a decision upon the request of the appellant and with the approval of an administrative law judge or the manager or chief administrative law judge of the appeals bureau. Requests for withdrawal may be made in writing or orally, provided the oral request is taperecorded by the presiding officer. An appeal may be dismissed upon the request of a party or in the agency's discretion when the issue or issues on appeal have been resolved in the appellant's favor.

The administrative law judge has reviewed the records and files herein and concludes that the request of the appealing party to withdraw the appeal should be approved.

DECISION:

The unemployment insurance decision dated March 23, 2021, (reference 02) is affirmed. The request of the appealing party to withdraw the appeal is approved, and the decision of the representative shall stand and remain in full force and effect.
