871 IAC 26.8(1) - Withdrawal of Appeal

STATEMENT OF THE CASE:

Wal-Mart Stores, Inc. (employer) appealed a representative's April 11, 2005 decision (reference 01) that concluded Vicki L. Gardemann(claimant) was qualified to receive unemployment insurance benefits, and the employer's account was subject to charge because the claimant had been discharged for nondisqualifying reasons. A hearing was scheduled on May 25, 2005. Prior to the hearing, the employer made a request to withdraw its appeal. Based on the employer's withdrawal request, the administrative record, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

FINDINGS OF FACT:

The employer's representative, TALX, made a written request to withdraw the employer's appeal. The employment submitted the request on May 17, 2005.

REASONING AND CONCLUSIONS OF LAW:

871 IAC 26.8(1) provides:

(1) An appeal may be withdrawn at any time prior to the issuance of a decision upon the request of the appellant and with the approval of the presiding officer to whom the case is assigned. Requests for withdrawal may be made in writing or orally, provided the oral request is tape-recorded by the presiding officer.

The employer's request to withdraw its appeal is approved.

DECISION:

The representative's April 11, 2005 decision (reference 01) is affirmed. The employer's request to withdraw its appeal is approved. The claimant remains qualified to receive unemployment insurance benefits as of March 13, 2005. The employer's account may be charged for benefits paid to the claimant.
