Section 96.3-7 – Recovery of Overpayment of Benefits

STATEMENT OF THE CASE:

Ronnie Kanetomo (claimant) appealed a representative's February 25, 2005 decision (reference 04) that concluded he had been overpaid \$906.00 in benefits he received for the weeks ending January 8 through February 12, 2005. The overpayment occurred as a result of a representative's February 18, 2005 decision that disqualified the claimant from receiving benefits as of January 2, 2005. After a hearing notice was mailed to the claimant's last-known address of record, a telephone hearing was held on March 16, 2005. The claimant participated in the hearing. Based on the evidence, the arguments of the claimant, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

ISSUE:

Has the claimant been overpaid \$906.00 in unemployment insurance benefits?

FINDINGS OF FACT:

The claimant established a claim for unemployment insurance benefits during the week of January 2, 2005. The claimant filed claims for the weeks ending January 8 through February 12, 2005. He received a total of \$906.00 in benefits for these weeks.

The claimant appealed a representative's February 18, 2005 decision that disqualified him from receiving benefits as of January 2, 2005. This decision has been affirmed. See decision for appeal 05A-UI-02047-DWT.

REASONING AND CONCLUSIONS OF LAW:

If an individual receives benefits he is not legally entitled to receive, the Department shall recover the benefits even if the individual acted in good faith and is not at fault in receiving the overpayment. Iowa Code §96.3-7. Based on the decision for appeal 05A-UI-02047-DWT, the claimant is not legally entitled to receive benefits for the weeks ending January 8 through February 12, 2005. The claimant has been overpaid \$906.00 in benefits he received for these weeks.

DECISION:

The representative's February 25, 2005 decision (reference 04) is affirmed. The claimant is not legally entitled to receive benefits for the weeks ending January 8 through February 12, 2005. This claimant has been overpaid and must repay \$906.00 in benefits he received for these weeks.
