871 IAC 24.2(1)g – Retroactive Weekly Claim

STATEMENT OF THE CASE:

Cynthia Roosa (claimant) appealed a representative's January 15, 2015 (reference 01) decision that denied the request for retroactive benefits for the period from December 21, through December 27, 2014. After due notice was issued, a hearing was held on February 25, 2015. Claimant participated personally.

ISSUE:

The issue is whether the claimant's request for retroactive unemployment insurance benefits should be denied.

FINDINGS OF FACT:

The administrative law judge, having heard the testimony and considered all of the evidence in the record, finds that: The claimant filed a claim for benefits with an additional date of December 21, 2014. She opened her claim correctly but did not report her weekly claim to the agency from December 21 through December 27, 2014 because she did not understand she was supposed to do so. The claimant requests retroactive benefits for the week ending December 27, 2014.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the claimant's request for retroactive benefits is denied.

Iowa Admin. Code r. 871-24.2(1)g provides:

Procedures for workers desiring to file a claim for benefits for unemployment insurance.

(1) § 96.6 of the employment security law of Iowa states that claims for benefits shall be made in accordance with such rules as the department prescribes. The department of workforce development accordingly prescribes:

g. No continued claim for benefits shall be allowed until the individual claiming benefits has completed a voice response continued claim or claimed benefits as otherwise directed by the department. The weekly voice response continued claim shall be transmitted not earlier than noon of the Saturday of the weekly reporting period and, unless reasonable cause can be shown for the delay, not later than close of business on the Friday following the weekly reporting period.

The claimant has not established sufficient grounds for having failed to file a weekly claim from December 21 through December 27, 2014. The claim for retroactive benefits is denied.

DECISION:

The representative's January 15, 2015 (reference 01) decision is affirmed. The claimant's request for retroactive benefits is denied.
