871IAC26.8(1) - Withdrawal of Appeal

STATEMENT OF THE CASE:

Paul W. Johnson (claimant) appealed a representative's August 15, 2003 decision (reference 05) that occluded he was eligible to receive benefits from July 13 through July 26, 2003 but would be denied benefits as of July 23, 2002. The claimant appealed this decision on March 16, 2004. A hearing was scheduled for April 6, 2004. On April 5, 2004, the claimant contacted the Appeals Section to withdraw his appeal. Based on the claimant's withdrawal request, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

FINDINGS OF FACT:

The claimant made a request on April 5, 2004 to withdraw his appeal. The claimant's withdrawal request was tape-recorded.

REASONING AND CONCLUSIONS OF LAW:

871 IAC 26.8(1) provides:

(1) An appeal may be withdrawn at any time prior to the issuance of a decision upon the request of the appellant and with the approval of the presiding officer to whom the case is assigned. Requests for withdrawal may be made in writing or orally, provided the oral request is tape-recorded by the presiding officer.

The claimant's request to withdraw his appeal is approved.

DECISION:

The representative's August 15, 2003 decision (reference 05) is affirmed. The claimant's request to withdraw his appeal is approved. The decision holding the claimant eligible for benefits from July 13 through July 26, 2003, but disqualified as of July 27, 2003 remains in effect.
