Iowa Code § 96.4(3) – Able to and Available for Work

**STATEMENT OF THE CASE:**

Derek J. Hannah, the claimant/appellant,<sup>1</sup> appealed the Iowa Workforce Development (IWD) May 28, 2024, (reference 05) unemployment insurance (UI) decision. IWD denied Mr. Hannah REGULAR (state) UI benefits as of May 19, 2024 because IWD concluded he did not report to IWD for an appointment, so he does not meet the requirement to be available for work. On June 10, 2024, the Iowa Department of Inspections, Appeals, and Licensing (DIAL), UI Appeals Bureau mailed a notice of hearing to Mr. Hannah and IWD for a telephone hearing scheduled for June 21, 2024.

The administrative law judge held a telephone hearing on June 21, 2024. The administrative law judge heard Appeals 24A-UI-05400-DZ-T, and 24A-UI-05401-DZ-T together and created one hearing record. Mr. Hannah participated in the hearing personally. The administrative law judge admitted Department's Exhibit 2, and Claimant's Exhibit B as evidence.

The administrative law judge concludes Mr. Hannah is eligible for UI benefits as of May 19, 2024, which is the Sunday of the week he contacted IWD to reschedule the appointment, because, although he missed the Friday, May 24, 2024 appointment, he contacted IWD that same day to ask for a new appointment.

**ISSUES:**

Is Mr. Hannah able to and available for work as of May 19, 2024?

Did Mr. Hannah report to IWD as directed by an IWD representative or offer justifiable cause for not doing so?

**FINDINGS OF FACT:**

Having reviewed the evidence in the record, the administrative law judge finds: Mr. Hannah applied for UI benefits effective February 11, 2024. In May 2024, IWD mailed Mr. Hannah a letter telling him that IWD would call him on Friday, May 24, for an appointment. Mr. Hannah's life was

full at the time due to the ending of the school year for his children and the death of a family member. Mr. Hannah did not check his mail, so he did not see the letter from IWD.

On Friday, May 24, an IWD representative left Mr. Hannah a voice message telling him that he missed the appointment. That same day, Mr. Hannah checked his mail, saw the letter from IWD, and called the IWD representative who had left him a voice message. The IWD representative did not answer so Mr. Hannah left a message asking to reschedule the appointment. Mr. Hannah called IWD again on Monday, May 27 and spoke with an IWD representative who told him about his appeal rights. The next day, IWD mailed Mr. Hannah the reference 05 UI decision denying him UI benefits as of May 19, 2024, which is the Sunday of the week of the appointment.

### **REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes Mr. Hannah is eligible for UI benefits as of May 19, 2024.

Iowa Code section 96.4(3) provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.19, subsection 38, paragraph "b", unnumbered paragraph (1), or temporarily unemployed as defined in section 96.19, subsection 38, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3 are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

Iowa Admin. Code r. 871-24.2(1)e provides:

e. In order to maintain continuing eligibility for benefits during any continuous period of unemployment, an individual shall report as directed to do so by an authorized representative of the department. If the individual has moved to another locality, the individual may register and report in person at a workforce development center at the time previously specified for the reporting.

(1) An individual who files a weekly continued claim will have the benefit payment automatically deposited weekly on a debit card specified by the department.

(2) The department retains the ultimate authority to choose the method of reporting and payment.

Iowa Admin. Code r. 871-24.23(11) provides:

Availability disqualifications. The following are reasons for a claimant being disqualified for being unavailable for work.

(11) Failure to report as directed to workforce development in response to the notice which was mailed to the claimant will result in the claimant being deemed not to meet the availability requirements.

UI rules require a claimant to participate in reemployment services unless the claimant shows justifiable cause for not doing so, or the claimant has previously completed the training or services.<sup>2</sup> If a claimant does not participate in the services without justifiable cause, the claimant is disqualified from receipt of UI benefits until the claimant participates in the services.<sup>3</sup> Justifiable cause includes an important and significant reason that a reasonable person would consider adequate justification in view of the importance of reemployment to the claimant. Not participating in the services or not showing justifiable cause means the claimant is not available for work.<sup>4</sup>

In this case, Mr. Hannah missed the May 24 appointment because he did not check his mail. But Mr. Hannah contacted IWD the same day and asked for a new appointment. Mr. Hannah is eligible for UI benefits as of May 19, 2024, the Sunday of the week he contacted IWD to reschedule May 24 appointment.

**DECISION:**

The May 28, 2024 (reference 05) UI decision REVERSED. Mr. Hannah is able to and available for work as of May 19, 2024. Mr. Hannah is eligible for UI benefits as of this date, as long as no other decision denies him UI benefits.

**APPEAL RIGHTS.** If you disagree with this decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at <https://www.legis.iowa.gov/docs/code/17A.19.pdf> or by contacting the District Court Clerk of Court <https://www.iowacourts.gov/iowa-courts/court-directory/>.

**Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.

Una decisión de la Junta de Apelaciones de Empleo es una acción final de la agencia. Si una de las partes no está de acuerdo con la decisión de la Junta de Apelación de Empleo, puede presentar una petición de revisión judicial en el tribunal de distrito.

2. Si nadie presenta una apelación de la decisión del juez ante la Junta de Apelaciones Laborales dentro de los quince (15) días, la decisión se convierte en acción final de la agencia y usted tiene la opción de presentar una petición de revisión judicial en el Tribunal de Distrito dentro de los treinta (30) días después de que la decisión adquiera firmeza.
