STATEMENT OF THE CASE:

Camden Christensen, the claimant/appellant, filed an appeal from the August 12, 2021, (reference 07) unemployment insurance (UI) decision that concluded he was overpaid Federal Pandemic Unemployment Compensation (FPUC) benefits in the amount of \$4,800.00. Mr. Christensen was properly notified of the hearing. A telephone hearing was held on October 15, 2021. Mr. Christensen participated and testified. The administrative law judge took official notice of the administrative record.

ISSUES:

Has Mr. Christensen been overpaid FPUC benefits?

FINDINGS OF FACT:

Having reviewed the evidence in the record, the administrative law judge finds: Mr. Christensen received FPUC benefits in the amount of \$4,800.00 for 8 weeks between May 24, 2020 and July 18, 2020.

FPUC is a program under the Coronavirus Aid, Relief, and Economic Security (CARES) Act of 2020 that provides additional payment to those individuals that are receiving state or federal unemployment insurance (UI) payments. It is funded by the federal government, not by state unemployment taxes paid by employers. The FPUC amount was \$600 per week from April 5, 2020 through July 31, 2020.

On July 23, 2020, Iowa Workforce Development issued a reference 04 decision finding Mr. Christensen was not eligible for REGULAR UI benefits because of a May 29, 2020 voluntary quit. Mr. Christensen appealed the decision to the Appeals Bureau of Iowa Workforce Development. The administrative law judge's decision in Appeal 21A-UI-05255-AW-T affirmed the reference 04 decision.

On February 23, 2021, Iowa Workforce Development issued a reference 06 decision finding Mr. Christensen was overpaid REGULAR UI benefits between May 17, 2020 and July 18, 2020. Mr. Christensen appealed the decision to the Appeals Bureau of Iowa Workforce Development.

The administrative law judge's decision in Appeal 21A-UI-05256-AW-T affirmed the reference 06 decision.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes Mr. Christensen has been overpaid FPUC benefits.

Iowa Code §96.3(7) provides, in pertinent part:

7. Recovery of overpayment of benefits.

a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

b. (1) (a) If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

PL116-136, Sec. 2104 provides, in pertinent part:

(b) Provisions of Agreement

(1) Federal pandemic unemployment compensation.--Any agreement under this section shall provide that the State agency of the State will make payments of regular compensation to individuals in amounts and to the extent that they would be determined if the State law of the State were applied, with respect to any week for which the individual is (disregarding this section) otherwise entitled under the State law to receive regular compensation, as if such State law had been modified in a manner such that the amount of regular compensation (including dependents' allowances) payable for any week shall be equal to

(A) the amount determined under the State law (before the application of this paragraph), plus

(B) an additional amount of \$600 (in this section referred to as "Federal Pandemic Unemployment Compensation").

....

(f) Fraud and Overpayments

(2) Repayment.--In the case of individuals who have received amounts of Federal Pandemic Unemployment Compensation to which they were not entitled, the State shall require such individuals to repay the amounts of such Federal Pandemic Unemployment Compensation to the State agency...

Because Mr. Christensen is disqualified from receiving REGULAR UI benefits, he is also disqualified from receiving FPUC benefits. While Iowa law does not require a claimant to repay regular UI benefits when the employer does not participate in the fact-finding interview, the CARES Act makes no such exception for the repayment of FPUC benefits. Therefore, the determination of whether Mr. Christensen must repay FPUC does not hinge on the employer's participation in the fact-finding interview. The administrative law judge concludes that Mr. Christensen has been overpaid FPUC in the gross amount of \$4,800.00 for 8 weeks between May 24, 2020 and July 18, 2020, which should be repaid.

DECISION:

The August 12, 2021, (reference 07) unemployment insurance decision is affirmed. Mr. Christensen has been overpaid FPUC benefits in the amount of \$4,800.00, which must be repaid.
