STATEMENT OF THE CASE:

The claimant, Marjorie J Stepp, filed an appeal from the November 16, 2022, (reference 01) unemployment insurance decision that denied benefits based upon the conclusion she was discharged for theft of company property. The parties were properly notified of the hearing. A telephone hearing was held on January 11, 2023. The claimant participated and testified. The employer participated through Owner Echo Boland. Exhibits A, B, C, D, E, F, G, H, I, J, K, L, 1, 2, 3, 4, 5, and 6 were admitted into evidence. The administrative law judge did not admit several of the claimant's exhibits because they were repetitive to existing payroll documents she submitted or were documents she created in preparation for the appeal.

After the record was closed, the claimant sent an email to the administrative law judge including more information regarding substantive matters. The administrative law judge forwarded this email to the opposing party, so that it was not an impermissible ex parte communication. The administrative law judge cannot and did not consider this information because the record was closed.

ISSUE:

Was the claimant discharged for disqualifying job-related misconduct?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds:

The claimant worked as a full-time cake decorator for the employer from August 2021, until this employment ended on October 19, 2022, when she was terminated. The claimant reported directly to the employer's owner, Echo Boland.

On October 19, 2022, the claimant was working the register at the employer's business. Early that morning, Ms. Boland sent a text message to the claimant asking her if she was in the shop. Ms. Boland asked the claimant when she would be leaving that day. At 7:17 a.m., the claimant spoke with her boyfriend Craig Kasal. Mr. Kasal would have to make a trip to Iowa City and he needed cash to get there and pay the valet. The claimant provided telephone records confirming

this call occurred. (Exhibit L) At 7:19 a.m. the claimant completed a transaction with a customer and pocketed cash from the transaction. The claimant did not ask for permission to borrow this cash. The claimant used sleight of hand to suggest she had placed the money in the cash register. The employer provided surveillance footage of the incident. (Exhibit 6) At 8:10 a.m. and 8:25 a.m., the claimant charged her credit card to offset the cash she took from these transactions. The employer provided a copy of these charges from a transaction report. (Exhibit 5) The transaction report shows perhaps one transaction occurred between these sales. The employer provided call records for the employer's business that shows no incoming calls came in between these two transactions. (Exhibits 1, 2, 3)

On October 20, 2022, Ms. Boland told the claimant not to come into work that day. The claimant asked why she was being terminated. The two women continued to argue through text messages until October 22, 2022. During that conversation, the claimant claimed that Ms. Boland approved her to charge her credit card on October 19, 2022 to offset the cash she took.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the claimant was discharged from employment due to job-related misconduct.

Iowa Code section 96.5(2)a provides:

An individual shall be disqualified for benefits:

2. Discharge for misconduct. If the department finds that the individual has been discharged for misconduct in connection with the individual's employment:

a. The individual shall be disqualified for benefits until the individual has worked in and has been paid wages for insured work equal to ten times the individual's weekly benefit amount, provided the individual is otherwise eligible.

Iowa Admin. Code r. 871-24.32(1)a provides:

Discharge for misconduct.

(1) Definition.

a. "Misconduct" is defined as a deliberate act or omission by a worker which constitutes a material breach of the duties and obligations arising out of such worker's contract of employment. Misconduct as the term is used in the disqualification provision as being limited to conduct evincing such willful or wanton disregard of an employer's interest as is found in deliberate violation or disregard of standards of behavior which the employer has the right to expect of employees, or in carelessness or negligence of such degree of recurrence as to manifest equal culpability, wrongful intent or evil design, or to show an intentional and substantial disregard of the employer's interests or of the employee's duties and obligations to the employer. On the other hand mere inefficiency, unsatisfactory conduct, failure in good performance as the result of inability or incapacity, inadvertencies or ordinary negligence in isolated instances, or good faith errors in judgment or discretion are not to be deemed misconduct within the meaning of the statute.

This definition has been accepted by the Iowa Supreme Court as accurately reflecting the intent of the legislature. *Huntoon v. Iowa Dep't of Job Serv.*, 275 N.W.2d 445, 448 (Iowa 1979).

Iowa Code section 96.5(2)b, c and d provide:

An individual shall be disqualified for benefits, regardless of the source of the individual's wage credits:

2. Discharge for misconduct. If the department finds that the individual has been discharged for misconduct in connection with the individual's employment:

b. Provided further, if gross misconduct is established, the department shall cancel the individual's wage credits earned, prior to the date of discharge, from all employers.

c. Gross misconduct is deemed to have occurred after a claimant loses employment as a result of an act constituting an indictable offense in connection with the claimant's employment, provided the claimant is duly convicted thereof or has signed a statement admitting the commission of such an act. Determinations regarding a benefit claim may be redetermined within five years from the effective date of the claim. Any benefits paid to a claimant prior to a determination that the claimant has lost employment as a result of such act shall not be considered to have been accepted by the claimant in good faith.

d. For the purposes of this subsection, "*misconduct*" means a deliberate act or omission by an employee that constitutes a material breach of the duties and obligations arising out of the employee's contract of employment. Misconduct is limited to conduct evincing such willful or wanton disregard of an employer's interest as is found in deliberate violation or disregard of standards of behavior which the employer has the right to expect of employees, or in carelessness or negligence of such degree of recurrence as to manifest equal culpability, wrongful intent or even design, or to show an intentional and substantial disregard of the employer's interests or of the employee's duties and obligations to the employer. Misconduct by an individual includes but is not limited to all of the following:

(1) Material falsification of the individual's employment application.

(2) Knowing violation of a reasonable and uniformly enforced rule of an employer.

(3) Intentional damage of an employer's property.

(4) Consumption of alcohol, illegal or nonprescribed prescription drugs, or an impairing substance in a manner not directed by the manufacturer, or a combination of such substances, on the employer's premises in violation of the employer's employment policies.

(5) Reporting to work under the influence of alcohol, illegal or nonprescribed prescription drugs, or an impairing substance in an off-label manner, or a combination of such substances, on the employer's premises in violation of the employer's employment policies, unless the individual is compelled to work by the employer outside of scheduled or on-call working hours.

(6) Conduct that substantially and unjustifiably endangers the personal safety of coworkers or the general public.

(7) Incarceration for an act for which one could reasonably expect to be incarcerated that result in missing work.

(8) Incarceration as a result of a misdemeanor or felony conviction by a court of competent jurisdiction.

(9) Excessive unexcused tardiness or absenteeism.

(10) Falsification of any work-related report, task, or job that could expose the employer or coworkers to legal liability or sanction for violation of health or safety laws.

(11) Failure to maintain any licenses, registration, or certification that is reasonably required by the employer or by law, or that is a functional requirement to perform the individual's regular job duties, unless the failure is not within the control of the individual.

(12) Conduct that is libelous or slanderous toward an employer or an employee of the employer if such conduct is not protected under state or federal law.

(13) Theft of an employer or coworker's funds or property.

(14) Intentional misrepresentation of time worked or work carried out that results in the individual receiving unearned wages or unearned benefits.

The decision in this case rests, at least in part, on the credibility of the witnesses. It is the duty of the administrative law judge as the trier of fact in this case, to determine the credibility of witnesses, weigh the evidence and decide the facts in issue. *Arndt v. City of LeClaire*, 728 N.W.2d 389, 394-395 (Iowa 2007). The administrative law judge may believe all, part or none of any witness's testimony. *State v. Holtz*, 548 N.W.2d 162, 163 (Iowa App. 1996). In assessing the credibility of witnesses, the administrative law judge should consider the evidence using his or her own observations, common sense and experience. *Id.* In determining the facts, and deciding what testimony to believe, the fact finder may consider the following factors: whether the testimony is reasonable and consistent with other believable evidence; whether a witness has made inconsistent statements; the witness's appearance, conduct, age, intelligence, memory and knowledge of the facts; and the witness's interest in the trial, their motive, candor, bias and prejudice. *Id.*

After assessing the credibility of the witnesses who testified during the hearing, reviewing the exhibits submitted by the parties, considering the applicable factors listed above, and using her own common sense and experience, the administrative law judge finds the employer's version of events to be more credible than the claimant's recollection of those events.

The administrative law judge finds the employer more credible for the following reasons:

1. The claimant submitted hundreds of documents purporting to show she was underpaid by the employer. These documents and the claimant's response to being terminated on October 20, 2022 show motivation or justification for taking the money.
2. The claimant claims in text messages exchanged with the employer that she was authorized to take the cash. During the hearing, the claimant acknowledged that she did not have such authorization to take the cash. In fact, the employer showed what little

conversation occurred between them before which confirms no such authorization was given.

3. The claimant feigned ignorance regarding what led to her termination until Ms. Boland informed her of the reason in the text message conversation from October 20, 2022 through October 22, 2022. This pattern of behavior does not seem consistent with innocence.

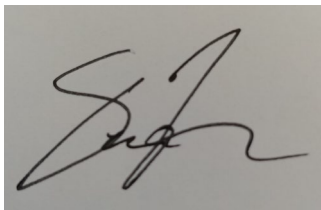
Taking cash from the register without authorization is theft from the employer. Theft from an employer is generally disqualifying misconduct. *Ringland Johnson, Inc. v. Hunecke*, 585 N.W.2d 269, 272 (Iowa 1998). In *Ringland*, the Court found a single attempted theft to be misconduct as a matter of law.

The claimant contends that she did not engage in theft because she offset what she took with charges to her credit card. The claimant continues that she was only seeking to get the right type of means of payment for her boyfriend rather than depriving the employer of that money. The administrative law judge does not find this credible for the reasons expressed above.

Even if the administrative law judge found such allegations credible, he would find the behavior disqualifying. Employers reasonably expect they can trust employees to not borrow money or otherwise misappropriate cash. The claimant was working a register on her own in a small business setting. These circumstances only heighten the expectation that employees use cash only for employer purposes unless authorized to do otherwise. The claimant was discharged due to disqualifying misconduct. Benefits are denied.

DECISION:

The November 16, 2022, (reference 01) unemployment insurance decision is AFFIRMED. The claimant was discharged from employment due to job-related misconduct. Benefits are withheld until such time as she has worked in and been paid wages for insured work equal to ten times her weekly benefit amount, provided she is otherwise eligible.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at <https://www.legis.iowa.gov/docs/code/17A.19.pdf> or by contacting the District Court Clerk of Court <https://www.iowacourts.gov/iowa-courts/court-directory/>.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
